1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. **Option Clause.** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. **Bidder Financial Standing:** The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Bidder shall submit the following documents along with their bid for Vendor Code Creation:-

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

5. **Experience Criteria:** The Bidder or its OEM {themselves or through reseller(s) should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

6. **Non-Disclosure Declaration Certificate.** (On Bidder Letter Head) to be uploaded with bid:-

(a). I M/s. Name of Firm hereby declare that I shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party during and after ex

piry of Contract.

(b) If defying the norms as per the Contract a legal action may be taken against me as per the existing Rules.

8. Registration / Empanelment Requirement. Contract shall be awarded to only such Sellers who are registered / empanelled / approved / enlisted with Min of Def for the required goods / service category on the date of bid opening. Prospective bidders (if not already registered), are advised to get themselves registered with the said registration authority before bid opening date. (It is certified that the registration is granted by the registering agency as per Rule 150 of GFR following a fair, transparent and reasonable procedure.)

9. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

10. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

11. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

12. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

13. **NET WORTH:** Net Worth of the OEM should be positive as per the last audited financial statement.

14. Following certificates will be provided/uploaded by the bidder:

(a) ISO 17025/ 9001 Certificate

(b) Bidder Turnover Certificate

(c) Experience Certificate

(d) Performance Certificate

(e) Identity proof of vendor (PAN, Aadhar Card).

(f) GSTIN Certificate

(g) Bid Security Declaration in Firms letter Head in-place of EMD

(h) Scanned copy of certificate in acceptance of terms and conditions of RFP on firms letter head

(j) OEM/ authorization/NSIC Certificate.

15. Certificates Bidder's offer is liable to be rejected if they don't upload any of the certificates/ documents sought in the Bid document, ATC and Corrigendum if any.

16. Turnover Bidder Turn over Criteria . The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

17. Turnover OEM Turn Over Criteria . The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

18. Past Project Experience The Bidder / OEM {themselves or through reseller(s)}, should have executed project for supply and installation / commissioning of same or similar Category Products during preceding 3 financial years (i.e. current year and three previous financial years) as on opening of bid, as per following criteria:

(i) Single order of at least 35% of estimated bid value; or

(ii) Two orders of at least 20% each of estimated bid value; or

(iii) Three orders of at least 15% each of estimated bid value. Satisfactory Performance certificate issued by respective Buyer Organization for the above Orders should be uploaded with bid. In case of bunch bids, the Category related to primary product having highest bid value should meet this criterion

19. OEM IMPORTED PRODUCTS : In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

20. **Warranty.** Timely Servicing / rectification of defects during warranty period: After having been

n notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service / rectification to the Buyer.

21. **Delivery location.** Garrison Engineer 881 Engineer Works Section, Poonch (J & K)-185101.

22. **Vetting of Reports should be got vetted from any NABL Labs** . A certificate from vetting agency on compliance to standards, codes, regulations in respect of safety soundness and economy shall be enclosed with the design folder. The consultant and vetting agency will be responsible for report deficiency.

23. On finalization of all reports, consultant shall submit 06 sets of completed report in hard copy (white print) duly signed and vetted as the case may be and soft copies in CD containing PDF of all signed sheets.

24. Contractor will make all the payment and bear expenses out of amount quoted. Contractor should go through all the expenses involved. The rates quoted by the contractor shall be including all taxes. In case of any doubt consultant can discuss with officer in charge of GE 881 EWS. No delay is acceptable & work has to be completed within 30 days. The contractor is responsible for any change/amendment required in reports after tender presentation/ during execution stage.

25. All payment shall be made after duly vetted by officer in charge AGE B/R of GE 881 EWS.

26. GENERAL CONDITIONS FOR STRUCTURAL DESIGN & PREPERATION OF STRUCTURAL DRAWINGS :-

(a) The contractor shall carryout the services required in terms of the contract agreement.

(b) In the event of defective reports noticed during execution, contractor shall be charged liquidated damage at the rate of 10% of the cost of deviation order necessitated due to revision of estimates. However, in case of minus deviation, no Liquidated damages shall be recovered from contractor.

(c) Completion certificate in r/o soil inv shall be issued by AGE B/R of this office.

(d) The bills along with connected documents will be subject to the pre audit prior to releasing payment. All taxes will be deducted at source, as applicable.

(e) Contractor must upload enlistment letter in the AOR of HQ CEUZ, Udhampur Zone issued from HQ CEUZ Udhampur Zone relevant category.

(f) If the soil inv services by the stipulated date is expected to get delayed due to any cause beyond your control, it shall be brought to the notice of this office immediately on the happening of the event causing delay in the completion of services, given notice thereof in writing to the accepting officer under intimation to the consignee who after consideration of circumstance causing delay in the services may grant reasonable extension of the completion.

(g) If at any time after placing the job order, the client decides to postpone or abandon the project, he may give seven days notice in writing to the contractor and terminate job order. If the project or any part thereof is postponed, the client may in lieu of terminating the job order request the contractor in writing to suspend carrying out of the services under this job order for the time being. If the client does not require the contractor to resume performance of his services in respect of any postponed work within 90 days from the date of suspension of carrying out of his services, such work shall be considered to have been abandoned and this job order shall be deemed to have been terminated.

(h) The contractor shall be eligible for payment of proportionate fees for the portion of soil inv services already rendered as assessed by the client. The client decision in this regard shall be final and binding. The other compensation what so ever shall not be paid.

(j) If the contractor commits any breach of any provisions of Job order the client shall be entitled to cancel the job order and on such cancellation the fees payable shall be proportion to the services if any already rendered by the contractor as assessed by the client less ten percent.

(k) All payment to the contractor shall be made through e-payment/NEFT AO, GE 881 EWS. NEFT mandate form shall be enclosed along with submission of original bill for payment. PI also ensure GST numbers are mentioned at time of submitting the bills. No additional amount will be paid for GST on work order placed.

(l) Prescribed pre stamped and receipted bill in triplicate will be submitted to the paying auth after fulfilling conditions mentioned above.

(m) Original copy of the above work order will be attached with bill. (n) In case the soil investigation services are not completed within the stipulated period the order will be cancelled without any liabilities what so ever towards the deptt.

(o) The contractor will liaise with the Engineer-in-Charge B/R of GE 881 EWS for obtaining any clarification on soil investigation.

(p) The Job shall be completed to the entire satisfaction of the GE 881 EW or an officer appointed b

y him.

(q) The decision of GE 881 EWS, the accepting officer shall be final and binding in case of any dispute. No applicant/ consultant shall be entitled for any compensation whatsoever for rejection of his application by the Accepting officer on eligibility criterion.

(r) The job shall be completed to the entire satisfaction of the Garrison Engineer or an officer appointed by him.

(s) Expenditure of the subject job work order is chargeable to subject code Head.

(t) The decision of GE 881 EWS, the accepting officer shall be final and binding in case of any dispute.

DETAILED OF THE PROJECT TO BE MANAGED BY SERVICE PROVIDER The contractor will revise the report without any financial effect if required during execution due to unforeseen circumstances.

PERIOD OF CONTRACT:

1. The period of contract arrangement shall be for 3 months from the date of supply order awarded.

RATES:

1. The bidders are required to quote all-inclusive offer (including GST also) for the contract on GeM portal. All base rates will be treated as firm for entire period of the contract arrangement and extension period.

2. The rates quoted by bidder should be inclusive of the following:-

(a) Cost of services/duties to be performed by Contractor as specified in this bid.

(b) Rates should include handling charges, delivery charges, transportation, accommodation of auditors & other incidental charges (if applicable).

(c) Expenses incurred by Contractor in preparation of reports, drawings, work completion certificate

e, invoices or any other documents and delivering the same to this Office.

(d) However, bidder is required to quote Taxes, as applicable, separately in the column provided in the Price Offer breakup sheet.

3. Bidders are requested to indicate their best rates together with maximum discount in the very first instance since further negotiations after opening of price offers is entirely at the discretion of the Corporation and may or may not take place.

4. Bidders are advised to exercise greatest care in entering the rates. No excuse for mistakes or requests for correction of rates will be entertained after the quotations are opened. All corrections, if any, should be initiated by the person signing the bid before submission, failing which the rates for such items may not be considered.

5. Any revision (increase/decrease) in statutory levy (GST) after awarding of the contract will be entertained, whenever revised, subject to production of proper documentary evidence in that respect. The revision shall be granted from the date of applicability of said revision in statutory levy. However, in the event, the GST is discontinued / reduced by the Government during the tenure of the contract/ extended period the benefit will be passed on to the Corporation. If the GST is increased by the Government during the tenure of the contract/extended period. The benefit will be passed on to the Contractor from the effective date of increase of GST, subject to the submission of documentary evidence for claiming such benefits.

TAX CLAUSE AS PER GOODS & SERVICES TAX (GST):

Registration & GST Rate :

1. Bidder should indicate GSTIN No. (Copy of GST registration to be enclosed) and PAN No. (copy of PAN to be enclosed).

2. Tender will be considered/ accepted, if & only if the vendor has a valid GST Registration No.

3. Central Tax/ State Tax/ Integrated Tax Union Territory tax to be quoted as extra in %.

4. Bidder to ensure correct applicability of Central Tax/ State Tax/ Integrated tax/ Union Territory tax based on the Inter/ Intra state movement Supply of goods and provision services or both.

Penalty for Non-compliance of GST Act :

1. Penalty amount so determined along with GST if applicable thereon shall be recovered from the

contractor.

EVALUATION:

1. Once a tender is accepted on technical grounds, then selection among such technically qualified bidder would normally be only on the basis prices quoted. However, the department reserves the right to reject all/ any of the tenders, and the decision of the department in this regard shall be final and binding.

2. The Bidder may take note that the award of contract would be on overall financial implication basis and the decision of the department for award of contract will be final and binding on the Bidder /s.

POINT OF CONTACT:

1. Once the tender is accepted and the contract is finalized, the contractor is expected to keep in touch with Maintenance & Services Department for further orders throughout the period of the contract and comply promptly with the orders, as per the specific requirements and instructions given by them from time to time.

2. The bidder should acknowledge receipt of Order immediately and confirm commencement of work as per the order.

RIGHT TO REJECTION:

Notwithstanding anything contained in this bid document, the department reserves the right to reject any Bid and to annul the Bidding Process and reject all Bids at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof. In the event that the Corporation rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder. The department reserves the right not to proceed with the Bidding Process at any time, without notice or liability, and to reject any Bid without assigning any reasons.

PENALTY CLAUSE:

The department has the right to take the following actions against the contractor, without prejudice to any of its rights, including the right to claim damages, if in case contractor is:-

1. Involved in wrongful billing:

(a) To issue a warning letter for the first contravention and recover the excess amount billed.

(b) On second contravention, to recover the excess amount billed and impose additional penalty of a sum of money to the extent of wrongful billed amount.

(c) On the next occasion of such wrongful billing, may even terminate the contract forthwith and forfeit the Security Deposit Amount.

IMPORTANT:

1. The bidder should be NABL or equivalent certification is reqd to be submitted with report. Soil investigation consultant shall have minimum 01 No ME M Tech (Geo Tech, Soil, Rock) with minimum 2 years' experience and 01 No BE, B Tech (Civ) with minimum 5 years and must have all adequate Tech Staff diploma, ITI qualified.

2. The bidder should have a minimum of two years' relevant experience in completing similar jobs during last 5 years ending last day of month previous to the one in which bids are invited.

3. Bidder must have positive net worth based on the audited balance sheet / profit & loss account during previous financial year (2024-25). Bidders are required to submit audited balance sheet and profit & loss account for FY 2022-23, 2023-24 and 2024-25. For proprietorship firms, proprietor's balance sheet, also, may be submitted.

6. In order to be considered for relaxation in prior experience and prior turnover for Startups, Startup India recognition certificate issued by Department of Industrial Policy and Promotion (DIPP) of Ministry of Commerce and Industry is required.

7. Any bidder belonging to Group of Companies should submit the work experience proof /relevant documents pertaining to relevant clauses mentioned in the tender document; on the name of 'tendering company name' only. Documents titling/showing combines or generic company name will not be accepted.

8. Site Visit/ Inspection is required prior participation in Bid.

9. Firm shall be enlisted for Soil Inv in the AOR of HQ Chief Engineer Udhampur Zone.
