If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Service & Support

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month." Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months

4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

This bid is prepared for the official use of officers mentioned in the consignee column.

The Models other than the specified vehicle models in the bid may be provided with the approval of the consignee officer.

1. Successful bidders may provide equivalent models other than specified in the technical column with approval of the consignee officer.

2. The vehicle deployed should mandatorily have the following documents:

- a) Valid R.C. Book.
- b) Valid FC for the vehicle arranged for transportation.
- c) Valid Comprehensive Insurance for the vehicle.
- d) Road Permit.
- e) Valid Pollution certificate.

Without the above documents it will be treated as Non deployment of vehicle and penalty will be imposed.

The original documents will also be submitted by him to CONSIGNEE OFFICER for verification if required.

3. The Tenderer should have the following documents.

- (i) PAN number of the Tenderer/ Firm.
- (ii) GST registration number of the Tenderer/Firm

4. The vehicles should be available as and when required by the CONSIGNEE OFFICER, SOUTHERN RAILWAY. On call, the driver of the vehicle should pick up or drop the Officials as directed.

5. The vehicle should have nice interior finishing and be road worthy with current fit certificate issued by competent authority.

6. In case of emergency, the vehicle has to be made available on Sundays and Closed holidays also. The contractor would be responsible for providing the vehicle round the clock even at short notice. The vehicle should be allowed to be engaged for other Railway officials also when instructed by the consignee.

7. The engaged vehicles should be used for the use of Railway Officials only. Outsiders should not be allowed.

8. The driver must be well mannered, well acquainted with local and outstation area and attend the duty of

n time in proper and clean uniform, with name badge , valid driving license, personal and/or accident insurance policy. The vehicle should not have met with any major accident.

9. The driver of the vehicle should be sufficiently equipped to meet the breakdown of the vehicle en route and for arranging the alternative vehicle. The expenditure for the alternative vehicle should be met out by the contractor.

10. The vehicle and the driver shall possess all relevant certificates like driving license, RC book, Emission certificate, FC, Comprehensive valid Insurance etc. Timely renewal of all the relevant documents / certificates is the responsibility of the contractor.

11. The contractor must ensure the safety of the driver engaged by him while executing the work. The contractor will be held responsible for any loss / damages to Railway property during the execution of work and the cost of damage / loss will be recovered from the contractor due to any category of accident.

12. It is desirable to have the residence of driver and parking of vehicle to be within 5 Kms from the Office of CONSIGNEE OFFICER.

13. The vehicle will be relieved for rest at respective headquarters or any other place during night for resuming duty the next day from that place. The duty hours for the vehicle will be closed at the time when the vehicle is relieved for rest . No detention charges will be paid during the rest period.

14. If required, Vehicles should be able to carry men and materials

15. The Tenderer shall indemnify the Railway Administration against any claim on account of any accident s/un-toward incidents due to the negligent act of the Driver that may arise during the pendency/termination of the contract.

16. The bidder must have an office located at Tamil Nadu. **Documentary evidence to be uploaded with the offer/bid.**

17. The contract duration may be extended on mutual consent for 6 Months beyond the original contract duration with approval of this contract issuing authority. In extension period, other terms and conditions remain the same.

18. The bidder should not have been blacklisted or debarred by any Central / State Government / Public Sector undertaking / Regulatory Authority of India at the time of submission of this bid : YES.

19. Railways has the right to cancel the contract with 15 days month notice period at no cost and without furnishing any explanation or reason.

20. The driver should have functional mobile phone ready to be contacted round the clock. Driver should be given adequate rest after night duty.

21. The vehicles should be provided necessarily with seat belts both in front and back seats. Good quality of seat covers with chained pockets, reading light & other basic amenities also to be provided. Necessary safety features like air bags, ABS, TPMS, ESC, etc should be provided.

22. It shall also be the contractor's sole responsibility to ensure that the vehicles are always and exclusively driven by a person appropriately qualified and licensed under the Motor Vehicle Act. It shall be contractor's sole responsibility to ensure that the driver of the vehicle: a) Have the necessary qualifications as laid in the Rules under the Central Motor Vehicles Act currently in force and any subsequent amendments there to. b) Are educated about the safety rules and regulations and abide by the same. c) Do not smoke or light a flame while driving the vehicle. d) Do not take any form of tobacco like cigarette, gutka, beedi, supari, za

... rda etc. during the contract period. e) Intoxication is prohibited during the contract period. f) Preferably have good knowledge of road routes, condition of roads etc. g) Shall be in possession of all relevant original documents pertaining to the vehicle such as Insurance policy, registration book etc. at all time while on duty.

23. Drivers should have sufficient money while on tour for the requirement of diesel, vehicle repairs and drivers food/accommodation etc.

24. The contractor shall be responsible for and shall pay any compensation to their employee payable under the Workmen's Compensation Act and the amendments there to for the injuries caused to the workmen.

The contractor shall be responsible for and pay the expenses for providing medical treatment to any of their employees whom may suffer any bodily injury as a result of any accident.

25. The contractor shall abide by the Payment of Wages Act/ Minimum Wages Act and other relevant Labour Legislation in force.

26. The contractor shall ensure ready availability of the following items at all time in each vehicle. a) one torch in good working condition b) Spares like hose pipes, fan belts, etc. c) Spare tyre in good condition d) Tool kit with all types of tools and tackles with jack. e) Portable Fire Extinguisher. f) First Aid Box

27. Vehicle should be neatly maintained.

28. All Hired vehicles should be equipped with prescribed emergency medical kit and a fire extinguisher as per statutory provisions.

29. The vehicle provided will meet the latest government standards for safety and pollution. The service provider to provide service in accordance with latest versions of Motor Vehicle Act.

30. The service provider shall comply with all rules & regulations issued by state/central government from time to time, applicable to this contract

31. Service provider has no authority to question the motive/travelling movement of the officer or vehicle.

32. The contractor should display a printed board in front and back of the vehicle with bold and words "G OVT. OF INDIA" while working against this contract.

33. Outstation Night charges are not applicable.

34. The payment cycle is monthly. Successful bidder to submit details about the vehicle like RC book, vehicle related documents only once during the contract. The documents may be asked again by the consignee/accounts only when the vehicle is changed or the submitted documents validity is expired.

35. Sufficient cash deposit should be made available with the driver to meet the emergencies such as repair, breakdown, Toll charges etc; during journeys.

36. The bidder should not have been backlisted or debarred by any Central / State Government / agency of central / state government / public sector undertaking / Regulatory authority of India at the submission of Bid.

37. FDR / Performance Security should be submitted by the firm to the Buyer within 30 days of the award of the contract on GeM. The payments to the contractor shall become due only after the receipt of FDR / Performance Security by the Buyer and verification of its genuineness. No interest shall be payable upon the Performance Security / PBG or any other amounts payable by the firm to the Buyer under the Contract.

38. The drivers of the vehicles deployed should maintain polite & courteous behaviour towards the buyer/passenger. "Misbehaviour" which may include, but not limited to, consumption of alcohol during or prior to duty, denial of duty during service hours as defined by user, use of abusive language, theft, shall attract deduction as per provisions of the contract.

39. The Service Provider will deploy experienced drivers knowing the routes of the areas and familiar with the localities for carrying out the services. The service provider shall be personally responsible for any theft, misconduct and /or disobedience on the part of drivers so provided by him.

40. If any break down occurs for the vehicle, alternative vehicle should be arranged by the contractor immediately in the quickest means as per instructions.

41. Year of model of vehicle may be provided upto 3 years from the date of opening of contract.

42. The Proof of Eligibility conditions of turnover, Experience Criteria etc shall be enclosed along with offer. Failing which offer will be rejected without further correspondences.

43. Bill Processing and passing authority is consignee department.

44. Driver should be well conversant in Local Language. Drivers should be well conversant in English or Hindi.

45. In line with Ministry of Finance letter No.F.20/2/2014-PPD(pt) dt 20.9.2016, in case of circumstances like procurement of items related to public safety, health, critical security operations and equipment etc., where purchaser may prefer the vendors to have prior experience rather than giving orders to new entities, for such procurements, wherever adequate justification exists, the purchaser may not relax the criteria of prior experience/ turnover for the MSEs. In this regard, in this bid exemption for experience to MSE is not given. But exemption to turnover is only given to MSE.

47. **Variation of the Contract** as per both parties' consent: The variation in the contract can be done through the following, however, the variation put together shall not reduce or exceed 25% of contract value:

a. Increase or decrease in the quantity of vehicles.

b. Increase or decrease in duration of contract.

This 25% variation is not applicable for extra km or extra hour payment.

48. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria only. As the contract is related to inspection, daily commute and sudden emergency movements of railway officials, prior experience is needed, subject to meeting of quality and technical specifications.

49. Instruction:

i. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

ii. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

iii. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

50. The contractor should arrange to submit copies of photo identity card, driving license of the Driver engaged before running of the vehicle to the respective officer/In-charge. All the formalities required for running

ng the vehicle in the road like registration, driving license for the driver, RC book, insurance policy, road tax clearance, Taxi Permit, other relevant records etc are to be arranged by the contractor and driver must keep the records so as to produce them for verification at any time by officials.

51. The contractor shall adhere to the Labour Rules, Workmen Compensation Act, Payment of Minimum Wages Act and other Labour Legislations.

52. The rate quoted by the tenderer for all the schedule items shall be inclusive of all the charges Viz. fuel, lubricants, repairs, maintenance charges, Salary, DA, EPF, ESI, Bonus, other allowances for driver, Toll charges, Entry fee and GST as mentioned in the schedule.

53. Vehicle to be stationed in Railway premises only when not in use.

54. Following items/facilities to be made available in the vehicle without fail - First Aid kit, Fire extinguisher properly attached, Mosquito bat, Umbrella, Sunshade for windows, Car Air freshener, White seat cover, Driver in uniform and other requirements as per extant rules. Penalty will be imposed if not adhering to these instructions.

55. Vehicle's fuel type may be Petrol/Diesel.

56. Consignee to inform contractor one day in advance if moving out of Tamil Nadu so that contractor can get necessary permits.

ELIGIBILITY CRITERIA:

1. **Work Experience:** Bidder should have completed satisfactorily in last three financial years and current financial year upto date of closing of tender, one same single service contract for a minimum of 35% advertised value of the bid.

2. **Financial Standing:**

a. **T1- Financial Turnover-** Bidder should have aggregate turnover not less than 1.5 times the advertised bid value during the last three previous financial years and in the current financial year upto date of closing of bid. The audited balance sheet reflecting the turnover certified by chartered accountant with stamp, signature and membership number shall be considered.

EMD clause:

EMD shall be 2% of estimate cost of the work rounded off to the higher nearest Rs.10

.

Performance Guarantee:

Performance Guarantee at a rate of 5% of the contractual value shall be deposited by the successful bidder within 30 days of date of issue of contract. If contract is extended beyond original contract period, then Performance Guarantee to be extended suitably.

8. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

9. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. 11. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

12. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

13. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. [Click here to view the file](#)

13. Reference of conditions published on any external site or reference to external documents/clauses.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
