3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. - Special Terms and Conditions for Motor Caravan/Vanity Van**

 - This category is created to cater to the requirement of buyer for procurement of Motor Caravan or Vanity Van. The application may vary and is required to be defined by the buyer in the bid. This category is a bid only category and procurement will occur exclusively through the bidding process.
 - The technical specifications and quantity for the additional attachments or constructional requirements like Seats, Tables, Sleeping Accommodation, Cooking Facilities, Storage Facilities,

Wash area (Toilet fitting, Bath fitting / shower, Wash basin), Water storage facilities (Fresh water tank, Gray water tank, black water storage etc.), Electricals (generator, Inverter, electrical appliances etc.) if required, shall be specified by the buyer in the bid.

3. In case fabrication is required by the buyer inside the body of the Vehicle, details and drawings/pictures may be provided by the buyer in the bid.
4. For listing a catalog on GeM, the seller may specify the price of the base vehicle. As the category is bid-only, the seller can submit their offer price while participating in the bid, based on the scope of work provided by the buyer.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. 7. **Buyer Added Bid Specific ATC**

- The Bidder must upload Copy of Pan Card, Valid character certificate issued by superintendent of police, Book Debts, along with Income Tax Return (ITR) Acknowledgement for last 3 years along with their offer.
- A factory photograph along with signboard as per GST norms must be uploaded of OEM.
- Bidder shall OEM authorization certificate as per appropriate format must be submitted along with the bid and OEM “Self - Declaration” along with documentary proof must be submitted along with Bid.
- The bidder should produce copy of valid ISO must upload along with technical bid. The certificate must be issued before the Bid publishing date.
- The bidder should submit Technical Specifications & Drawings of the offered equipment.
- The bidder should be registered with appropriate Government authority as an organization. Copy of valid registration proof must be submitted.
- The bidder should be registered with the Goods and Service Tax department and comply with monthly/Quarterly tax returns.
- Bidders are required to upload all documents as specified under the Pre-Qualification Criteria (PQC). Failure to upload any mandatory document shall result in outright rejection of the bid.
- All submitted documents must be self-attested by the authorized signatory of the bidding firm. Non compliance with this requirement may render the bid non-responsive.
- Declaration of the following points are required on non-judicial stamp paper in state of Rs. 1000 from Executive Magistrate after the Bid Published:

- 1) The Bidder/OEM has to declare that all the documents submitted by them in the Bid are true & genuine to the best of their knowledge.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
