1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product

offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Special terms and conditions-Version:1 effective from 05-12-2024 for category Plastic Bottle Booth

1. Special Terms and Conditions for Plastic Bottle Booth

1. This category is created to cater to the requirement of buyer for procurement of Plastic Bottle Booth. The constructional and the site requirements may vary and is required to be defined by the buyer in the bid. This category is a bid only category and procurement will occur exclusively through the bidding process.
2. The technical specifications for dimensions of Plastic Bottle Booth shall be defined by the buyer in the bid as per the range provided in the category parameters. In case the requirement lies outside the range provided in the category, GeM may be requested to update the range.
3. The thickness of the Mesh/Steel Rod/Bar/Sheet used in the Bottle Booth shall be defined by the buyer in the bid.
4. Furthermore the details of signage and paint/finishing requirements shall be defined by the buyer in the BID.
5. The buyer shall define the site conditions and details on civil work required in installation, if required.
6. For listing a catalog on GeM, the seller may specify a reference average price based on the selections done in the category . As the category is bid-only, the seller can submit their offer price while participating in the bid, based on the scope of work and requirements provided by the buyer.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- The bidder must hold a valid GST registration in the same state as the buyer, i.e., Kerala. The GST registration must be in the name of the bidding Organization. Furthermore, bidders are required to submit proof of regular monthly GST return filings for the past years, counted up to the date of bid publication.
- Bidders must have maintained continuous and active participation on the Government e Marketplace (GeM) platform for a minimum period of 2 consecutive years. Appropriate documentary proof confirming this requirement must be submitted along with the bid.
- All bidders are required to operate from a legally registered office within the state of Kerala. They must possess a valid Goods and Services Tax (GST) registration issued by the Government of India, which must remain active at the time of bid submission. Additionally, bidders should hold a valid office operation license as mandated by the relevant authorities in Kerala. Supporting documents for both GST registration and operational licensing must be submitted along with the bid.
- Bidders must possess a GEM rating of at least 4 stars. The bid should include supporting documentation of the rating and reviews, as well as a valid GEM Gold Certificate.
- Proof of adherence to any Additional Terms and Conditions (ATCs) stated by the procuring authority must be provided. These ATCs may include specific contractual duties detailed in the official bid documents.
- The bidder must be either an OEM or an OEM authorized dealer. If the bidder is an OEM authorized dealer, they must submit a bid-specific Manufacturer Authorization form.
- A formal declaration on the company's letterhead must confirm that the bidder has not been banned or declared ineligible to participate in public procurement by any government entity within the past years.
- Only products that exactly meet the technical specifications outlined in the bidding document will be considered. Any discrepancy between the offered product and the required specifications will result in disqualification during the technical review stage.
- The purchasing authority retains the exclusive right to approve or reject any offer based on its own assessment of the products in the market. The authority is under no obligation to justify its decision, and no disputes will be entertained in this regard.
- To demonstrate technical and regulatory competence, bidders must submit an ISO 9001:2015 certificate for quality management
- If there are any deviations from the specified technical or general requirements, bidders must clearly list these in a Technical Deviation Statement, which should be uploaded as part of the bid package.
- After the contract is awarded, the sticker design and content will be provided by the Bid Inviting authority, and the seller must affix the sticker on the plastic twin bin at no additional cost.
- The bidder must submit the diagram (With Measurements) of the bottle booth.
- To be shown by sample before opening tender.
- If None of these documents is found then your tender will be rejected.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
