3. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Period of Contract: - Initially contract is for One year which can be extended upto Three years depending upon the satisfactory performance of service with the approval of the competent authority.

2. The firm/contractor who have been debarred/blacklisted by any Deptt./Autonomous body of the central/ State Government and MC Chandigarh are not eligible to apply. In case these facts are established after allotment of the contract, then such contract will be terminated after due inquiry without any notice and in such an eventuality the security deposit will stand forfeited. The undertaking/ affidavit regard to non-blacklisted/debarred and proceeding not pending, must be uploaded by the firm.

3. The bidder will be bound to comply with all other conditions specified at the time of sign agreement along with bid T&C & ATC.

4. Leave: The successful bidder shall ensure that apart from paid holidays for Holi, Ambedkar Jayanti, Balmiki Jayanti and Diwali, manpower will be entitling for 12 leaves in a year i.e one leave per month. These leaves will be carry forward in every month and will lapse at year end of the calendar year.

5. In case it is found or in case it is reported that the contractor is not paying the full salary of their workers, then a fine up to Rs. 50/- per worker/per day shall be imposed by the office, which can be waived off by the HGS, SPCA after found genuine reason from the agency. In case the contractor repeatedly defaults in paying the wages in full or part then the Municipal Corporation Chandigarh shall be at liberty to terminate the contract. If, 7th day of month happens to be a holiday, the next working day should as a routine be treated as due date.

6. EPF/ESIC/Bonus/Minimum Wages: The contractor will be responsible for fulfilling all his obligations towards the persons deployed under law, namely, under the Minimum Wages Act, EPF/EDLI, ESIC Act, Bonus Act as applicable and amended from time to time. The contractor will be responsible for deposit of employees and Principal employer's share of statutory contribution towards ESIC/EPF/EDLI with the concerned department/authorities at his own level before the stipulated date as per Act and maintain such record as per rules. The contractor will be required to submit a copy of challan/ abstract/statement of the amount deposited on payment and only submit EPF and ESIC statements generated by official website of EPF and ESIC will be required to submit with the ensuing monthly bill every month, failing which the payment of the following month will be withheld. 7. 8. 9. al Corporation Chandigarh by the contractor in advance or on demand. Further, the contractor will ensure that no financial or any other legal liability comes of the Municipal Corporation, Chandigarh in this respect at any time for the acts done by the person of the Contract.

10. Successful Bidder shall submit the electronic Performance Security (ePBG) in favour of Commissioner MCC at Chandigarh.

11. The contractor shall ensure that all the workers has insured with the scheme PMSBY & PMJJBY.

12. Identity Card: - The contractor should provide identity card within 15 days after allotment of Bid to all employees appointed under terms and conditions of contract in the name of their firm. However, proof sample (Identity Card) need to be approved by the office of MOH, Municipal Corporation, Chandigarh.

13. Performance security: The successful bidder shall submit the electronic performance security within 15 days after allotment of bid, failing which the penalty @Rs. 5000/- per day will be imposed to the contractor, the same can be waived off by the HGS, SPCA after found genuine reason from the successful bidder.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
