3. Delivery period will be as mentioned in BOQ from date of supply order.
4. No extension on the job will be granted.
5. Acceptance of additional buyer specific terms and conditions required.
6. All items will be provided as per make and technical specification mentioned in BOQ/RFP please read technical specification carefully before participation.
7. **Self-declaration certificate that the route upto the FOR site has been reced and there are no issues with respect to route/site for supply of the equipment. A certificate of recce carried out by the firm representative duly Countersign by the representative of unit should be uploaded along with the Bid. No representation for route difficulty or inadequate load capacity of bridges enroute will be entertained. L1 vendor will be quote amounts inclusive of all the transportation charges upto the FOR site.**
8. Compliance of Tender Document duly sign and stamped to be uploaded.
