**Traders/Resellers/Distributors/Authorized Agents will not be considered for availing benefits under PP policy 2012 for MSE as per MSE guidelines issued to MSME office memorandum F.M. 22(1)/2012-MA dated 24.10.2016 and they have to submit EMD without fail.**

In case of Non-MSE Indigenous Bidders, bid shall accompany interest-free EMD for **Rs. 85,000/-** (Rupees Eighty Five Thousand Only)
