- a. Bidder shall quote overall bid price on lumpsum basis which shall include the price of all the BOQ items as tabled above and PRICE breakup BOQ attached for ready reference.
  - i. Hiring Charges: Bidder shall quote hiring charges of bus @ Rs per day basis
  - ii. Running Charges: Bidder shall quote @ Rs / KM.
- b. No other charges of any other nature shall be paid to vendor during the course of contract except Toll and Parking charges, if any on actual basis and on certification of EIC.
- c. Evaluation shall be on over all quoted prices inclusive of GST.

4. Location: Bus shall be deployed at Kerendari Coal Mining Project, NTPC LTD, Hazaribagh District, Jharkhand, PIN 825311. However, Bus may also be required to stay out of Hazaribag / Project site for NTPC's work at the discretion of the Engineer-In-Charge.
5. Payment Terms: All payment due to the contractor will be payable on completion of a month in the subsequent month after receiving proper bill from the contractor in the prescribed format along with supporting documents as may be needed from time to time. Such payment will be based on the documentary evidence of Utilization of the vehicles which will be based on the logbooks /Trip sheets, a copy of which is to be submitted by the contractor along with his bills. Payment due, if any will be based on verification of such documents.
  - a. Hiring Charges: RA bill on monthly basis.
  - b. Running charges: Shall be paid @ Rs / KM.
6. Amount linked to Safety aspects: 2 %. The 'Amount linked to Safety Aspects / compliance to Safety Rules' is 2% of contract value. The same shall be retained from each Running Bill and shall be released in part or full based on safety compliance duly certified by EIC and Safety-in-charge in subsequent RA bill.
7. NIL DEVIATION: Subject tender is NIL Deviation tender, hence bidder shall not take any deviation against tender conditions and specifications. Deviation mentioned, if any in the bid or in clarification shall stand withdrawn unconditionally without any additional financial implication.

In case bidder refuse to withdraw additional conditions/deviations/ variations/ exception, implicit or explicit, found anywhere in the techno-commercial bid, the bid shall be rejected as Technically non-responsive.

8. All other terms and conditions for the contract shall be governed by SOW and NTPC GCC and SCC applicable for service package.
9. The order of precedence of documents: Scope of work and NTPC GCC and SCC attached in GEM bid document shall have precedence over any other documents attached like Domain Specific STC of Particular Service including its SLA (Service Level Agreement), GEM GTC and ETC.,

10. Deployment period : Deployment with in **07 (Seven) days from the date of issue of GEM Order** / as per instruction of EIC.

Hence the bidder must, at the time of submission of bid, **should possess the requisite Bus** in good working condition conforming strictly to the prescribed technical specifications and shall submit the above mentioned necessary vehicle documents.

11. Further, bidder shall ensure and declare the vehicle model and variant to be deployed along with the support of RC copy at the time of bid submission, no fresh option to declare alternate vehicle Reg no, shall be entertained.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
