1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. PRE-QUALIFICATION CRITERIA (PQ)

–

- i. GST Registration of the vendor should be from the State of Kerala. (GSTIN beginning with the numerals 32)
- ii. The service provider should have a registered office in Kerala and a local office at Ernakulam District of Kerala State against which documentary proof needs to be submitted for qualifying the bid.
- iii. All proofs sought in the ATC shall be compiled into a single document titled **“Related Documents.”** The documents must be scanned and arranged in the same order as specified in the ATC. Failure to submit the documents in the prescribed manner will result in the quotation not being fully scrutinized, and at the stage of variation, such quotation shall be liable to rejection.

2. Scope of Work

1. **Cochin Special Economic Zone Authority** intended to hire one Sedan vehicle with the following specification for a period of two year and extendable by one more year.

The vehicle with the above specifications shall be provided to the office of the Chairperson, Cochin Special Economic Zone Authority, Kakkanad, Ernakulam for the official use of office of Chairperson, CSEZA, Kakkanad.

- iii. The distance covered by hired vehicle will be calculated starting from the office premises to which they are assigned. The vehicles would normally be utilized from 08:00 hrs to 22:00 hrs; the operational hours may be extended beyond this period on a 24X7 basis, for local as well as outstation trips, without any prior notice to the contractor, should the requirement arise.
- iv. The driver(s) should be proficient in Malayalam and should possess a valid driving licence, be experienced, maintain decorum and discipline and, be familiar with local roads and locations.
- v. The driver(s) should report for duty in clean, white uniforms, and be available on a mobile phone during duty hours. The contractor should ensure that all drivers are supplied with a cell phone. A list of contact numbers of the drivers should be submitted to the Vehicle officer by the successful contractor.
- vi. The driver(s) should adhere to the instructions of the Vehicle Officer.
- vii. The driver(s) should be prepared for outstation journeys on short notice, as indicated in para 1.
- viii. A daily record of time and mileage for each vehicle shall be maintained in a log book which should be submitted to the Vehicle officer for scrutiny.

3. PERIOD OF CONTRACT / CANCELLATION OF CONTRACT

- i. The period of contract shall be initially for two years from the date of the issue of the work order, and it is extendable by one year subject to satisfactory performance by the supplier.
- ii. The tentative start date of the contract shall be 01.04.2026 or upon completion of the selection of the service provider through GeM and issuance of the work order, as decided by the Competent Authority.
- iii. Chairperson, CSEZ Authority reserves the right to terminate the contract at any time without assigning any reason, for which no compensation shall be paid. **The actual period of contract starts from the date of receipt of Work Order.**

4. PAYMENT TERMS

- i. Payment will be released within 15 days on submission of bill alongwith necessary documents and certified by the Officer-in-Charge.

- ii. Services provided to a Special Economic Zone Developer are exempt from payment of GST. Accordingly, the qualified service provider shall execute a valid Letter of Undertaking (LUT) with the GST Department for availing GST exemption and shall comply with all applicable statutory requirements in this regard.

ADDITIONAL TERMS & CONDITIONS FOR HIRING VEHICLES

1. GST Registration of the vendor should be from the State of Kerala, copy of the registration may be submitted. (GSTIN beginning with the numeral s 32)
2. The service provider should have a registered office in Kerala and a local office at Ernakulam District of Kerala State against which documentary proof needs to be submitted for qualifying the bid.
3. During the period of contract, no request shall be entertained for any hike in the agreed rates due to any reason what so ever.
4. Any person who is in government service or an employee of the department is not eligible to quote as Service Provider.
5. A sign board bearing "On Duty" "Government of India, Ministry of Commerce", should be displayed on the vehicle in bi-lingual (English and Hindi) both in the front and rear sides.
6. Any excess or short run kilometres will be adjusted in the subsequent months until the end of the contract.
7. In case of dispute, the decision of the Chairperson, Cochin Special Economic zone Authority, Kakkanad shall be final and binding.
8. All disputes arising out of or in any way connected with the agreement shall be deemed to have arisen at Kochi and only courts in Kochi shall have jurisdiction to determine the same.
9. The bid amount should be exclusive of GST. In this regard, the qualified service provider shall execute a valid Letter of Undertaking (LUT) with the GST Department for availing GST exemption and shall comply with all applicable statutory requirements.
10. The service provider should own at least one vehicle of this contract.
11. The service provider should have a minimum of 3 years' experience in the related field.
12. Interested parties must present the vehicle at the office of the Chairperson, CSEZA, Kakkanad for inspection during the technical evaluation. Absentees will be rejected on technical grounds.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses

on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
