Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 2. Generic

- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Service & Support

SPECIAL CONDITIONS HIRING OF TRUCK

1. The truck is required for the use of SSE-PWAY-MIYAGAM KARJAN of Engineering department of Vadodar

a division.

2. Capacity of required truck is 8 to 10 MT.

3. Truck Model like Tata, Eicher , or Similar like Standard. Note-19 feet open body LCV Truck.

4. The vehicle so offered shall not be older more than 2024.

5 . Loading and Unloading will be done by the Railway administration.

6. The contractor have to submit 5% EPBG in form of DD/FDR/BG of nationalized bank within 15 days from issue of Gem Contract and if not submitted within 15 days' time period,

(A) No Payment of hiring of vehicle shall be made to the contractor till the submission of 5% EPBG by the contractor, it is mandatory to provide EPBG within 15 days before comissioning of contract.

7. Road Vehicle provided for hiring contract shall be owned by the bidder and RC book shall be in favour of bidder or if not owned, in such cases an affidavit on stamp paper for hired vehicle provided from other sources shall be submitted by bidder and prior approval of competent authority of railway to be obtained.

8. The driver provided for the hired vehicle by the bidder shall be having valid RTO Heavy Vehicle License & registered with Government Labour Department and salary details of driver shall be provided by bidder with monthly bills.

9. No deviation in the Railways standards and specification/terms and conditions of bid shall be acceptable by Railways.

10. The Monthly Bill cycle will be maintained by the contractor and online bills will be submitted for payment through GeM Portal.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
