The Annual Turnover (ATO) of the bidder during any of the preceding three financial years (2022-23, 2023-24 & 2024-25) should be at least Rs. 29,63,25,000/- (Rs Twenty-Nine Crore Sixty Three Lakhs Twenty Five thousand only)

13. Reference of conditions published on any external site or reference to external documents/clauses.

15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
