## 12. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

a. The tenure of engagement for any of the positions covered under this bid shall be co-terminus with the appointment of regular/permanent staff against the corresponding roles. In such cases, the Buyer shall provide a minimum of one month's prior notice to the Service Provider to facilitate adequate intimation to the deployed personnel, enabling them to explore alternative career opportunities.

b. In case a resource provided by the agency resigns, in order to address the issue of attrition, the agency shall provide a resource within 15 days of resignation. In case of non-compliance suitable action as per GeM Provisions shall be taken that may lead to deduction of bill claim, and may further lead to forfeiture of PBG/Security Money and cancellation of contract in case of repeated violations.

c. These posts are contractual and will not be treated as regular employees of NCDC. They will have no claim for regular employment under NCDC.

d. It is to be notified that the Manpower is to be deployed at **NCDC, Guwahati, Assam Branch**, and the bidder has understood the scope of work and must mandatorily be required to deploy as per the contract obligation, including T & C and additional T & C mentioned in the bid and the bidder must submit an undert

aking on its letter head in this regard.

e. The manpower on contractual basis through GeM, initially for 2 year, along with 5% annual increment per year, and further extension for a period of one year as per GeM provision incorporated provision of GeM generic clause, however, the same can be extended further or till regular incumbents join on mutually agreed terms and conditions s.to. approval of the competent authority.
