OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. Buyer Added text based ATC clauses

1. THE ADVANCE SAMPLE TO REACH THIS UNIT LOCATION ONE DAY PRIOR BEFORE OPENING OF TECHNICAL BID.
2. THE BIDDER WILL BE DISQUALIFIED IF ADVANCE SAMPLE NOT PROVIDED FOR INSPECTION OF BOARD OF OFFICER.
3. THE VENDOR SHALL PROVIDE WARRANTY CARD OF ALL RELEVANT ITEMS IF APPLICABLE DULY SIGNED AND STAMPS DURING ACTUAL DELIVERY ITEMS AS PER BID.

#### 6. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

#### 7. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

#### 8. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
