1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

## Terms and Conditions for Printing Tender

### 1. Eligibility and Registration

- **Location:** The Agency/Party must be registered within the state of **Gujarat**.
- **Documentation:** The Agency must submit their **GST Registration Certificate** and **PAN Card**.
- **Experience:** A minimum of **three (3) years of experience** in providing printing services to Government or Semi-Government organizations is mandatory.
- **Financial Standing:** The Agency must have a minimum annual turnover of **₹2.6 Crores**. A **CA Certified Turnover Certificate** for the last three years (2022-23, 2023-24, and 2024-25 [up to Dec-25 if possible]) must be submitted.

### 2. Delivery and Service Standards

- **Timeline:** The printing of modules/booklets must be completed and delivered to the institute within **05 to 07 days** of receiving the order.
- **Urgency:** The Agency must be capable of providing immediate printing services as and when required.
- **Logistics:** No transportation charges or allowances will be paid by this office for the delivery of printed materials.
- **Quality Check:** Payment will be processed only after the provided materials are inspected and found satisfactory.

- **Specifications:** Printing must be done according to the number of pages specified for various trainings/workshops. Samples will be provided by this office in soft or hard copy.

### 3. Deposits and Financial Guarantees (EMD & Security)

- **EMD Exemption:** Micro, Small, and Medium Enterprises (**MSME**) are exempt from Earnest Money Deposit (EMD) as per the procurement policy.
- **EMD for Others:** All other units must submit an **EMD of 3%** of the tender value as per the *Gujarat State Procurement Policy - 2024*. This should be a refundable Demand Draft in favor of "**State Institute of Health and Family Welfare Other**" (Payable at Punjab National Bank, Waghodia Road Branch, Vadodara) and sent via **RPAD/Speed Post** before the tender deadline.
- **Security Deposit:** The successful bidder must deposit a **Security Deposit of 5%** of the tender value via Demand Draft within **10 days** of tender approval.

### 4. Legal and Compliance

- **Affidavit:** A notarized undertaking on **₹300/- Stamp Paper** stating that the agency is not blacklisted and has no ongoing court cases must be submitted (dated after the tender publication).
- **No Sub-Contracting:** The Agency is strictly prohibited from sub-contracting the assigned work to any other contractor.
- **Default Clause:** If the Agency fails to provide services satisfactorily within the time limit, the contract may be canceled. In such cases, services will be sought from the **L2 Agency at L1 rates**.
- **Quantity Variation:** There will be a provision for a **25% increase or decrease** in the estimated value and quantity of the tender.

### 5. Penalties

- **Late Fees:** In case of delay in printing work, a weekly late penalty fee of **0.5% of the order value** (up to a maximum of **10%**) will be recovered from the Agency.

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
