2. Certificates

3. Generic

4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidders shall quote delivered unit rates inclusive all duties, taxes, transit insurance, packing, forwarding & freight charges etc.
- Bidder to consider recent announcement regarding GST rate modification by GOI while for the tender.
- Evaluation shall be carried out on delivered value to the Company.
