The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

  3. The bidder/OEM must submit valid NABL-accredited laboratory test reports for these product and same should be uploaded at the time of bidding
4. The Bid has to be quoted by bidder with valid BIS License Certificate with BIS Product Listed IS-16018 Certificate for Water Mist Wheel Type Fire Extinguisher.
5. A minimum fire rating of 233B for B class fire for 45Ltrs. Water Mist Trolley Mounted Fire Extinguisher is mandatory for participation. Otherwise, the OEM/bidder will be disqualified for not meeting this requirement.
6. The bid has to be quoted by bidder for all items, single item bid shall not be considered.

8. Bidder should upload the soft copy of EMD and submit the same EMD before last date of bid at this division office.
9. Bidder should upload last 3 months GST upto date returns.
10. GST Registration Certificate and Latest upto date due GST return of the State in which the work is to be taken up, if already obtained by the bidder.

If the bidder has not obtained GST registration in the State in which the work is to be taken up, or as required by GST authorities then in such a case the bidder shall scan and upload following under taking along with other bid documents. "I

f work is awarded to me, I/we shall obtain GST registration Certificate of the State, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by CPWD, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by CPWD or GST department in this regard.

## अस्वीकरण/Disclaimer
