1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. 4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this

criterion.

7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

8. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 9. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

11. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Generic

7. Rate Contract

- (i) Inhibit the desires and designed function of the equipment.
- (ii) Cause physical damage to the user or equipment during the exploitation.
- (iii) Tap information resident or transient in the equipment/network.

(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

10. Generic

1. The EMD should be submitted to this office along with covering letter of Firm/Agency. The Covering letter should contain full postal address along with the Pin code, email ID, Mobile Number/Land Line Number. It should be signed by concerned authority of the Firm/Agency.
2. The rates quoted online will only be considered for selection of the bids. The firm/supplier should accept the same and effect the supply in the event of selection of their quotation and receipt of supply order from this office.
3. The general conditions applicable to the contracts placed by the Indian Council of Agricultural Research, New Delhi and its Institutes and special terms and conditions detailed hereafter shall also apply.
4. The Tenderer shall submit his tender only in case he has experience in the field of supply of feed referred and he is in a position to take up the same.

6. The Tenderer after submission of his tender shall not reverse or modify the rates, terms and conditions of the tender, failing which the EMD deposited by him shall be forfeited and further action will also be taken against the firm by the Director, DPR.

6. Only in the event of the offer not being accepted by this office, the EMD will be refunded.

7. The EMD and ePBG shall not carry any interest.

8. The entire tender documents may be submitted/returned in tact as per the serial page numbers and without removing any pages.

9. The tender may be ignored, if complete information required is not given therein or if the particulars asked in the tender and the documents connected with the tender are not furnished completely. However, Director DPR may relax such requirements at any time, if it is felt that such relaxations are necessary to increase number of technically qualified bidders to encourage competition for the benefit of this Institute.

10. Tenderer is required to specify whether he signs in the capacity of "sole proprietor" or "partner of the firm." In such case, he must have the authority to refer to arbitration dispute concerning the business of the partnership.

11. In case of partnership firms, where no authority to refer disputes concerning the business of the partnership has been concerned on any partner, every partner of the firm must sign the tender and other related documents. A person signing the tender form or any other documents forming part of the tender on behalf of another person shall be deemed to warranty that he has authority to bind such other person. The Directorate shall have discretion to place purchase order(s) for any excess/less quantities than the mentioned tender notice depending upon the actual requirements as and when needed only. The quantity of feed ingredients mentioned in our above tender is for a period of 3 months. The duration may likely to be increased or decreased at discretion of the Director of this Directorate. The selected firm should supply the feed ingredients as per our requirement for which payment will be released after certification of the goods by officers of DPR.
 6. The requirements of goods shall be worked out from time to time by the In-charge, Feed Processing Unit of this Directorate. The contractor shall be obliged to supply the requisite material within five (5) days from the date of receipt of communication from the I/C Feed of this Directorate.
 7. The Director reserves the right to reject a part or entire tender without assigning any reasons.
 8. GST applicable, if any, should be mentioned in the online financial bid.

9. The Director at his discretion can change/relax the terms and conditions mentioned in the tender document at any time for the best advantage to this Directorate.
10. Any clarification, if required in this matter, may be obtained from this office on any working day before closing date of the tender.
11. Payment for the supplies made will be released after obtaining analysis report from the nutrition laboratory of this Directorate. It will be ensured that the payment will be released within a reasonable time. In case the feed ingredients supplied are not as per our specifications, the consignment will be rejected. However, if the quality falls within the acceptable range, pro-rata deduction will be made, taking the analysis report into account.
12. Insurance charges incurred by the contractor, if any, for transportation and till the delivery of the goods shall be borne by the contractor/firm.
13. Supply of all feed ingredients shall be made only on working days between 9.30 a.m. to 12.30 p.m. at the godown of the Directorate.
14. Any consignment brought into the Campus prior to or after the prescribed hours shall not be accepted and will be left outside the godown/DPR at the risk of the supplier.
15. Supply should be made against the net weight of the ingredient excluding the weight of the Gunny, Synthetic bags.
16. For convenience, the gross weight of each empty Gunny bag is taken as 0.75 kg. and for the plastic bag as 0.25 kg.
17. After receipt of the consignment, the Grain Inspection Committee of the Directorate shall usually examine the quality of the material supplied. The recommendation of the Grain Inspection Committee shall be final either to accept the material in part or full or to reject the material.

The security deposit of the contractor/firm shall be utilized to pay the difference between the prevailing cost of the material and the accepted rate in the tender.
21. Loading and unloading of feed ingredients from and at this Directorate's godown shall be the responsibility of supplier. No hamali/labour service will be extended by this Directorate. A minimum of 4 hamalis must accompany with each consignment.
22. **The tenderer should have a Local Office/Branch Office in the state of Telangana preferably nearest area of Hyderabad for easy communication/ personal presence at the time of delivery of consignments. Documentary evidence in this regard to be enclosed with the tender.**
