### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 7 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

### 5. Inspection

10. The LED products must comply with all relevant BIS (Bureau of Indian Standards) specifications and carry necessary safety certifications (e.g., CE, RoHS).
11. The successful bidder shall be responsible for the comprehensive supply, transportation, installation, testing, and commissioning of the LED lights at the designated sites.
12. The bidder is responsible for conducting a pre-installation site survey to determine exact requirements and ensure compatibility.
13. Any minor civil or electrical work required for the installation (e.g., wiring, mounting) shall be included in the scope of work.
14. The products shall carry a minimum comprehensive warranty of 02 years from the date of final acceptance.
15. In the event of any defect, manufacturing flaw, or performance degradation (e.g., reduced luminosity) during the warranty period, the bidder must replace the unit entirely within 48 hours of notification, at no additional cost to the client.
16. All maintenance, repairs, and replacement activities are the sole responsibility of the bidder. The client will not provide technical support, labor, or tools for these activities.
17. Service Level Agreement (SLA): The bidder must guarantee a minimum uptime of 98%.

18. Failure to rectify defects or replace faulty items within the stipulated time frame will result in a penalty of 20% of the contract value per day of delay, deducted from the retention money or pending invoices.

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
