C. Delivery period being 60 days from the date of each Call-up - An official call-up will be issued by the Kolkata/Silvassa Plant through email after the award of the contract for their respective requirements.

The successful bidder must ensure that the material for each call-up is delivered to the respective Plant within 60 days from the date of issuance of that call-up. Each lot/batch should be accompanied by the manufacturer's test certificate and approval of quality report.

Any material delivered without email confirmation/ call up or with a quantity greater than mentioned in call up, may not be accepted at plant and bidder will have to take the material back. No request from bidder in this concern shall be entertained by any of the Balmer Lawrie officials.

If the bidder fails to deliver the material within 60 days from the date of call-up, Liquidated Damages (LD) at the rate of 0.5% per week, subject to a maximum of 5%, shall be applicable.
