If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for

Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25 % percentage of total quantity. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

Special terms and conditions-Version:2 effective from 18-08-2025 for category Solid Cushion Tyres (V3)

1. **Special Terms and Conditions for Solid Cushion Tyres (V3)**

1. The category: "Solid Cushion Tyres" is to cater to the requirements of

procurement of Solid Cushion Tyres. This category is bid only category and Direct Purchase is not enabled.

2. The buyer may specify the details of the vehicle for which Solid Cushion Tyres are required.
3. Details on environmental conditions, working conditions and specific application may also be included by the buyer in the bid.
4. Details on warranty shall be specified by the buyer in the bid.
5. The buyer may verify that the supplied tyre is not more than 6 months old from its manufacturing date.

### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 1. Technical Compliance & Freshness

Standards: All tyres must be of current year manufacture and bear a valid ISI Mark as per BIS Specification S.

Freshness: Tyres must not be older than 6 months from the date of delivery. Date of Manufacturing (DOM) must be clearly visible on the sidewall.

#### 2. Local Vendor Reservation (50 KM Radius)

Requirement: To ensure immediate emergency replacement and technical support for the Police Department's 24/7 operations, this bid is reserved for vendors having a registered Service Center or Main Office within in a 50 km radius of Narsinghpur.

Proof of Presence: Bidders must upload and submit a GST Registration Certificate or Shop & Establishment License showing a business address within this 50 km radius.

#### 3. Mandatory Physical Submission (Hard Copy)

Submission Policy: A physical set of all technical documents uploaded on GeM must be submitted in a sealed envelope.

#### 4. Professional Fitment & Alignment

Services: Rates are inclusive of professional fitment at the vendor's local Narsinghpur workshop using automated tyre-changing machines.

Alignment/Balancing: Every set of tyres must undergo 3D Computerized Wheel Alignment and Computerized Wheel Balancing.

Nitrogen: Tyres must be inflated with Nitrogen (N2) at the time of fitment for high-speed safety.

#### 5. Mandatory Document Checklist

Original Manufacturer Authorization Form.

Experience: Copies of previous GeM Contracts or Work Orders from Police/Govt. departments.

Warranty: Minimum 1-year warranty certificate from the OEM.

Affidavits: Self-declaration of Non-Blacklisting and Local Content (MII) on company letterhead.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
