1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
5. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority : Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25 % of total quantity as defined/ decided in relevant policy.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity

supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

##### 1. Scope and Nature of Procurement

1.1 The GeM (Government e-Marketplace) is hosting online bids for the procurement of 4 (Four) Earth Augers for use in various plantation and field activities under the administrative control of the Divisional Forest Officer, Gurdaspur Forest Division, Gurdaspur, Punjab.

1.2 Bidding shall be conducted under the Two Packet Bid System, comprising:

- i. Technical Bid, and
- ii. Financial Bid.

1.3 Bids shall be submitted online only through the GeM portal ([www.gem.gov.in](http://www.gem.gov.in)). Submission of bids in any offline mode is strictly prohibited, and any such bid received shall be summarily rejected.

1.4 The GeM bid, upon acceptance (in whole or in part), shall automatically stand converted into a contract, governed by the GeM General Terms and Conditions (GTC), applicable Special Terms and Conditions (STC), and these Buyer Added Bid Specific Additional Terms and Conditions (ATC).

##### 2. Eligibility and Qualification Requirements

2.1 The bidder must be either:

- The Original Equipment Manufacturer (OEM) of the offered Earth Auger(s), or
- An authorised dealer/distributor of such OEM.

2.2 In case of an authorised dealer, an OEM Authorisation Certificate on OEM letterhead, addressed to the Divisional Forest Officer, Gurdaspur, specifically authorising the bidder to quote for this specific GeM bid, shall be uploaded in the Technical Bid. If the bidder is the OEM, a self-declaration on OEM letterhead confirming OEM status shall be uploaded.

2.3 A valid manufacturing proof held by the OEM, verified and stamped by GM-DIC of the concerned district, shall also be uploaded in the technical bid.

2.4 The OEM shall possess a valid ISO 9001 certification accredited by the National Accreditation Board for Certification Bodies (NABCB) and shall be uploaded in the technical bid.

2.5 The bidder and its OEM shall possess valid GST registration and PAN, and legible copies of GST Registration Certificate and PAN Card of both the bidder and OEM shall be uploaded with the Technical Bid.

2.6 The bidder and OEM shall meet the Minimum Average Annual Turnover requirement for the last three financial years (FY 2022-23, 2023-24 and 2024-25) as specified in the GeM bid. Documentary evidence in the form of audited balance sheets or a certificate from a Chartered Accountant shall be uploaded.

2.7 To fulfil the Experience and Past Performance criteria, the bidder/OEM shall have supplied the same or similar category equipment to any Central/State Government Department / PSU / Autonomous Body during any one of the last three years, as specified in the bid document. Copies of work orders/contracts/completion certificates shall be uploaded.

2.8 The bidder shall upload in the Technical Bid a valid Test Certificate, issued by a testing laboratory accredited as per ISO/IEC 17025:2017 by NABL/IQAS for the relevant test parameters. The Test Certificate must explicitly confirm compliance with all specifications, dimensions, and material grades prescribed in this bid. The bidder shall also upload the laboratory's accreditation certificate for verification purposes. The date of the Test Certificate shall not be older than 90 days from the date of publication of this bid.

2.9 The OEM shall provide an undertaking for warranty for a period of 12 months from the date of supply, covering any manufacturing defects, quality defects, defective raw materials, or poor workmanship.

2.10 Affidavit executed on non-judicial stamp paper of at least Rs. 100/- and duly attested by a First Class Magistrate, shall be submitted along with the technical bid. The affidavits shall declare that neither the bidder nor its OEM/OEMs have ever been suspended/blacklisted, or disqualified by any Buyer Organisation, State Government, Union Territory, PSU, Central Government, or any other Government organisation for non-performance of contractual obligations, violations, or breach of any statutory Acts and laws.

### 3. Earnest Money Deposit (EMD)

3.1 A soft copy of the Earnest Money Deposit (EMD), as specified in the GeM bid document, shall be submitted online through the GeM Portal ([www.gem.gov.in](http://www.gem.gov.in)). The original Demand Draft/Bank Guarantee shall also be submitted to the office of the bidding authority on or before the bid end date and time. Bidders are advised that MSE OEMs are not exempt from furnishing bid security. Failure to submit the bid security by any such bidder shall result in outright rejection of the technical bid.

3.2 Non-submission of EMD (where applicable) shall result in outright rejection of the Technical Bid.

### 4. Inspection, Demonstration and Acceptance

4.1 The Divisional Forest Officer, Gurdaspur, or his authorised representative(s) shall have the right to inspect the supplied Earth Augers at the time of delivery or at any time during the warranty period.

4.2 The successful bidder shall arrange an on-site demonstration of operation, routine maintenance and safety practices of Earth Augers at the location(s) specified by the Buyer, for the staff of the Forest Department, without any additional cost.

4.3 Acceptance of the supplied items shall be subject to satisfactory inspection, demonstration and verification of compliance with the ordered specifications. Non-conforming or substandard material may be rejected, and replacement shall be done by the supplier at its own cost, without any financial liability on the Buyer.

### 5. Rates, Taxes and Validity

5.1 Rates shall be quoted inclusive of all taxes and duties (including GST), freight, packing, forwarding, transit insurance and all incidental charges, on FOR destination basis for any consignee within Gurdaspur Forest Division.

5.2 The rates approved under this bid shall remain firm and valid for a period of 1 (one) year from the date of contract/order placement, and the successful bidder shall remain bound to supply additional quantities, if required, at the same rates and terms during this period, subject to GeM rules on quantity variation.

5.3 No price escalation shall be admissible during the currency of the contract, except if specifically allowed under GeM provisions and configured in the bid.

### 6. Contract Performance, Risk and Termination

6.1 If the Supplier fails to deliver the stores or any instalment thereof within the period fixed for such delivery in the contract, or at any time repudiates the contract, the Buyer shall be entitled to take action as per GeM GTC including imposition of LD, cancellation of contract, and procurement at the risk and cost of the Supplier.

6.2 The Department shall not be responsible for any loss, damage, or injury occurring to the goods during transportation, handling, or storage prior to formal acceptance. The Supplier shall be solely responsible for such risks until acceptance.

6.3 The Buyer may, by written notice, terminate the contract in whole or in part if the Supplier fails to perform any of its contractual obligations or violates any condition of the contract, without prejudice to other remedies available under law and GeM rules.

#### 7. Representations, Clarifications and Corrigendum

7.1 Any representation or clarification sought by bidders shall be submitted only through the online GeM portal within the time window prescribed in the bid. No offline representation shall be entertained.

7.2 The Divisional Forest Officer, Gurdaspur, reserves the right to issue corrigendum / clarification / amendment to this bid and ATC through the GeM portal only. Bidders are required to regularly monitor the GeM portal for any such updates and shall be deemed to have taken note of all corrigenda while submitting their bids.

#### 8. Governing Law and Jurisdiction

8.1 This GeM Bid and the resultant Contract shall be governed by and construed in accordance with the laws of India.

8.2 The courts at Gurdaspur (Punjab) alone shall have exclusive jurisdiction over any disputes arising out of or in connection with this GeM bid or the resultant contract, subject to GeM dispute resolution mechanisms as applicable.

#### 9. Reservation of Rights

9.1 The Competent Authority reserves the right to accept or reject any or all bids, wholly or partly, at any time without assigning any reason and without incurring any liability to the affected bidder(s).

9.2 Submission of a bid on GeM shall be deemed to imply unconditional acceptance by the bidder of all terms, conditions and specifications contained in the GeM GTC, applicable STC and this Buyer Added ATC.

### 3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
