If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public

Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

10. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

11. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

4. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

6. Inspection

7. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

8. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. TERMS AND CONDITIONS FOR JOB WORK

1. OEM / Authorization

The bidder should be the Original Equipment Manufacturer (OEM) or an authorized dealer/supplier of the OEM. Authorized dealers must submit a valid authorization certificate from the OEM, failing which the bid shall be technically rejected.

2. Site Visit and Technical Understanding

Before bidding, the bidder must visit, examine, and understand the technical requirements of this office. The bidder shall upload a certificate stating that:

"We have visited the office premises and understood all technical parameters/requirements of the software/system."

The bidder must also upload the software flow chart along with the bid.

(a) The bidder is advised to visit and examine the installation site and its surroundings and obtain, at their own responsibility and cost, all information necessary for preparing the bid.

(b) Entry of the bidder's representative shall be permitted into the consignee's premises for such visits, as the supply and installation are to be executed in a restricted area having security implications (Ministry of Defence office).

(c) The bidder shall not be entitled to claim any compensation from the buyer due to lack of prerequisite information. It is the sole responsibility of the bidder to obtain all necessary information regarding the site, s

surroundings, working conditions, etc., before submission of the bid.

3. Warranty

Supplied items shall carry a warranty period of 3 years (unless otherwise specified). Only genuine spares/parts shall be supplied. The bidder shall rectify any defects or carry out repairs required during the warranty period without additional cost.

4. Execution in Restricted Area

The job work shall be executed in a restricted area with security implications and working hour restrictions. The supplier must obtain prior permission from the buyer and coordinate accordingly before execution of the job.

5. Final Authority

The decision of the Competent Engineering Authority shall be final and binding in all matters.

6. Failure to Perform

If the bidder fails to execute the work or does not perform as per the contract order/terms/ATCs, the buyer reserves the right to cancel the order, either in full or in part, after due approval of the Competent Engineering Authority.

7. Rates

The bidder shall quote competitive rates in figures and words for the entire job as per the Scope of Work. Rates shall include credit for all scrap/credit materials and shall also include free delivery/repair/replacement of spares at the consignee's premises/work site.

8. Inspection Before and After Execution

The job/stores/items/workmanship shall be inspected by the concerned Board of Officers (BOO)/Inspecting Officer before execution and/or upon completion. If not found up to the required standards and specifications, or in case of any discrepancy in quality or quantity, the Inspecting Officer may reject any or all items.

9. Dispute Resolution and Rejection

In the event of any dispute between the Inspecting Officer and the firm, the matter shall be referred to the GE, whose decision shall be final and binding.

The department reserves the right to accept or reject any or all items without assigning any reason. Rejected stores shall be removed/replaced immediately by the supplier at their own risk and cost.

10. Technical Documents and Delivery

The vendor may upload technical brochures or supporting documents along with the bid. The job/stores shall be supplied/completed within the date specified in the job order.

11. Scope of Work and Additional Terms

(a) The agency may communicate via the GeM portal regarding clarifications related to the job order.

(b) The agency shall employ only Indian nationals after verifying their antecedents and loyalty. No person with a doubtful background shall be engaged.

(c) The job/workmanship/vehicle/equipment for repair/replacement/supply shall be handed over to the authorized representative of the firm against a stamped receipt voucher.

(d) The agency shall be fully responsible for the accuracy, quality, and stability of the work. The completed job/vehicle/equipment shall be delivered inside the consignee's premises.

(e) In case of failure to perform as per contract terms, the buyer reserves the right to cancel the order in full or in part after due approval of the Competent Engineering Authority.

(g) The manufacturing company must have at least one showroom/display center/authorized branch/registered office in India. A valid GST registration certificate must be uploaded. Supplied items shall carry a minimum warranty of 1 year (where applicable).

(h) The scope of work shall include all contingent works necessary for complete and technically sound execution, even if not specifically mentioned. No extra payment shall be admissible on this account.

(i) If at any time during the contract the agency's performance is found inadequate or unsatisfactory, the contract may be terminated by giving 5 days' written notice, without any liability to the department.

(j) Material Test Certificates, if required as per the bid, shall be submitted along with supply. Materials shall be checked by the Engineer-in-Charge. Test results of an authorized laboratory shall be final for acceptance.

12. Inspection

(a) The job ordered shall be subject to inspection by a nominated Inspection Authority to ensure conformity with specifications. The Accepting Officer reserves the right to conduct a second inspection within six months.

(b) Irrespective of inspection, if within 12 months from completion any defect in design, workmanship, or material is noticed, the same shall be rectified/replaced by the firm at site without additional cost. The Accepting Officer's decision shall be final.

13. Consignee

The Consignee shall be AGE (B/R)-V, Mhow. The job/stores shall be consigned on a freight prepaid basis. Accepted rates shall be for delivery at destination, including delivery inside the consignee's premises.

14. Completion Certificate

A Completion Certificate shall be issued by AGE (B/R)-V, Mhow upon satisfactory completion of the job.

15. Payment Instructions

(a) Payment shall be made after completion of work and inspection/acceptance by the authorized representative/Board.

(b) Pre-stamped, pre-receipted bills in triplicate shall be submitted to the paying authority.

(c) The original copy of the job order shall be attached to the bill.

(d) The bill shall be subject to pre-audit by the associated finance authority.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
