II. TERMS AND CONDITIONS:

- Service completion period:** Party has to complete the total repair work within One month from date of GeM order date.
- Repair works is on TURKEY BASIS which includes replacement of damaged part with new one and others while execution, fixing of same and transportation is in service scope.
- Quote should be valid as per GeM bid.
- All materials are to be entered at BDL Bhanur-CISF Gate.
- All debris/waste generated during service activity will be shifted to Central scrap yard through prescribed challan is in scope of service contract.
- Contractor has to visit the site on working day towards technical parameters, dimension & design before quote by submitting request mail to bdlbgped.ap@bdl-india.in.
- Warranty shall be provided for the executed services for the period of one year after completion of subject work.
- The Site-in-charge is Mr. Sarvesh Kumar Verma, PE (PED-CP) & Mr. Soma Srinivas, CE (PED-PMS GMS) & Engineer-In-charge is Mr. Puneet Kumar Singh, Mgr (CP-PED & Electrical).
- Contractor may be called for Price Negotiation if required.

10. **Safety Terms:** While working on site, your personnel should follow all safety precautions with PPEs & any hindrance in the working area at BDL is not responsible for any accidents to your service personnel. Insurance & all other incidents are in your scope to the extent of his liability under workmen's compensation ACT 1923 & others. BDL is not responsible for any direct or indirect accidents to your service personnel. Vendor has to arrange all the necessary safety devices like Helmets, Safety Shoes etc. for carrying out the entire work.

III. PAYMENT TERMS:

1. 100% Payment will be paid after completion of the each inspection/service call and submission of the following documents.
 - a. Original GEM Invoice and GST invoice with two copies.
 - b. Service reports.
2. **L.D.Clause:** If the Seller fails to deliver any or all of the Goods/Services within the original/re-fixed delivery time-period(s) specified in the Contract, BDL reserves the right to deduct/recover from the seller, the Liquidated Damages for the delay, unless covered under Force Majeure conditions afore-said, @ 0.5% per week or part of the week of delayed period as pre estimated damages not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever.
3. BDL reserves its right to release GST only after supplier's invoice/debit note is reflected in GSTR-2B/2A within the specified time limit mentioned in GST law.
4. Invoice should contain GeM contract no, contract period, Description & Rates as per Contract order.
5. **Statutory deductions** as applicable will be deducted while releasing the payment.

IV. ELIGIBILITY CRITERIA:

1. **Experience Criteria:** Vendor shall have *relevant experience in repairs / machining / fabrications* and documentary evidence must be submitted in bid participation for eligibility.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-

compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
