If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

Terms & Conditions:

- i. *Minimum Average Annual Turnover of the service provider must be more than 1 Crore in last 3 years ending on 31st march of previous financial year.*
- ii. *The service provider's performance during the last three years should have been consistently satisfactory to government departments. The Past project Experience Required for Same/Similar Product/Service must be either of the following in three years completed by the bidder:

 - a. *one contract of similar service equal to 80% of the estimated bid value or*
 - b. *Two contracts of similar service equal to 50% of the estimated bid value*
 - c. *Three contracts of similar service equal to 40% of the estimated bid value**
- iii. *The Service Provider must own at least 30 % of the bid quantity of vehicles in Service Provider's name or in the name of the company/ proprietor / partner or relative (including the husband, wife, brother , sister, or any lineal ascendant or descendant) of the Service Provider. Registration Certificate of vehicle establishing proof of ownership (indicating the relation in case vehicle is owned in name of relative) will be uploaded by the bidder for verification of the buyer.*
- iv. *The vehicles to be deployed by the service provider must be in good condition and no vehicle model more than 5 years old should be deployed at buyer's location.*
- v. *The Service Provider must have at least 30 % drivers of the bid quantity.*

- vi. Minimum 50% of vehicles demanded must have been provided in the past 1 year to government agencies by the bidder. Necessary documents must be submitted by the bidder.
- vii. An office of the service provider must be located in Surat (Gujarat). Certified documentary evidences by local authority must be submitted.
- viii. The Bidder's offer is liable to be rejected if they don't upload any of the required certificates/documents sought in the bid specifications and terms & conditions.
- ix. Bidder must have dedicated /toll free telephone nos. for service support
- x. Bidder/service provider must provide escalation matrix of telephone numbers for service support.
- xi. The bidder must have a proven track record of providing similar services to a Central/State Government, or a Public Sector Undertaking (PSU) for a continuous period of three years leading up to the bid opening date. However, preference may be given to such service provider, who has been rendering their service to the Income Tax Department.
- xii. Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent) on existing terms and conditions.
- xiii. The buyer/Department reserves the right to increase or decrease the quantity to be ordered up to 25 percent at the time of placement of contract. The buyer also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- xiv. During the contract period if any vehicle is utilized more than the prescribed monthly kilometres limit, then it will be adjusted against unutilized mileage of such vehicle in preceding/succeeding month and if excess kilometres not adjusted completely then adjustment will be made against remaining cumulative mileage of other hired vehicles at the end of the Contract period. If any unadjusted utilized kilometres still remain after said adjustments, the payment will be made at the end of contract period at the rate mentioned in contract at Rs. 12/- per km.
- xv. Without prejudice to buyer's right to price adjustment by way of d

discount or any other right or remedy available to Buyer, it may terminate the contract or part thereof by a written notice to the seller if

- xvi. the seller fails to comply with any material term of the contract.*
- xvii. the seller informs buyer of its inability to deliver on contract as agreed upon.*
- xviii. the seller has misrepresented the buyer, acting on which misrepresentation Buyer has placed the order on the seller.*
- xix. the seller fails to deliver as per contract.*
- xx. Payment of Salaries and Wages - Service Provider is required to pay salaries/ wages of contracted staff & vehicles deployed at buyer location first i.e. on their own and then claim payment from Buyer along with all statutory documents like PF, ESIC etc. as well as the bank statement of payment done to staff & vehicles, it is considered to be one of the material terms of contract.*
- xxi. Bidders should submit the EMD in the form of Demand Draft payable at State Bank of India in favor of ZAO, CBDT, Surat @ 5 % of bid value along with the bid. The proof of EMD should be uploaded/submitted along with the bid and bidders are also required to submit physical copy of EMD in the office of the Chief Commissioner of Income Tax, Surat on or before bid's end date.*
- xxii. The successful bidder must also require to submit e-PBG (Performance Bank Guarantee) within first month of execution of contract. Failure on part of the bidder may result in cancellation of contract without any prior intimation.*

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
