1. 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the date of delivery order and in cases where option clause is exercised during the extended delivery period the addition shall be up to the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original period}$  (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time shall be 30 days. The Purchaser may extend this calculated delivery duration up to the original delivery period while the bidder must comply with these terms.

## 2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

## **Submission of Shop Establishment Certificate**

The bidders must submit a valid Shop Establishment Certificate issued by the appropriate authority of the Territory of Andaman and Nicobar Islands. The Certificate must be up to date and renewed before the date of bid submission. Bids without a valid and updated certificate shall be considered rejected at the initial stage.

## **Delivery Supply Schedule**

The contract is divided into four quarters, each comprising a three-month period. The bidder shall deliver the specified goods within the first month of each quarter.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to extant Order under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category restriction.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached](#) items, the bidder shall comply with the approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying Indian standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
