2. 3. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

5. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

3) INVOICE: In the event of award of Contractor supplier should upload physically signed Invoice Copy on Gem Portal well before expiry of contractual delivery period for Payment purpose and Hard Copy of the Invoices should be forwarded to Pay and Accounts Officer, RRCAT, PO CAT, Indore, MP-452013 on priority.

5) Note - Performance Security Bank Guarantee:- Supplier has to ensure delivery of hard copy of the original BG/DD to the Buyer within 15 days of award of contract with a validity period of 20 Months .

6) GST Certificate consisting of Annexure-A & B shall be furnished along with your offer.

7) Acceptance criteria: All the specification mentioned in the tender will be tested at RRCAT and after it passes all the test the item will be accepted.

8) Instructions to Bidders :

a) Submission of Technical Documentation: Bidders shall submit comprehensive technical documentation, including the official product catalogue and a detailed datasheet, for each item quoted.

b) Product Specifics: For all standard, catalog-listed products, the submitted documentation must clearly show the manufacturer's name, part number/model number, and all relevant technical specifications.

c) Verifiability: The provided catalogues must be authentic, current, and verifiable by the Purchaser, either through a physical copy or a link to the manufacturer's official website.

d) Mismatch of Information: In case of any unexplained mismatch between the information provided in the bid and the supporting documents (catalogue/datasheet), the bid is liable for rejection.

e) Mandatory Requirement: The submission of the product datasheet and a verifiable catalogue is a mandatory requirement for technical qualification. Failure to provide this information will render the offer non-responsive and will be summarily rejected.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
