The vendor should agree this at time of bid submission and submit all the required documents along with technical bids. Bidders, who wish to offer Car which is not in their possession as on the due date/extended due date of tender can also participate along with **a booking slip & an affidavit in the prescribed format** that they will have physical possession of the vehicle along with all statutory licenses within 7 days from the date of issue of LOA. Booking slip in the name of the applicant (**either the proprietor or the firm**) is required to be submitted along with the affidavit. Car offered against a affidavit shall be physically positioned at the location within 7 days from the date of issue of LOA / Work Order, failing which EMD submitted in respect of the Car so offered shall be forfeited. Booking is to be carried out through authorized sales representatives / show rooms of the Original Equipment Manufacturers. Receipt of booking shall be attached along with the tender documents.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
