Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. (a) OEM/Manufacturers shall only be allowed to participate in the instant tender enquiry.

(b) This is a Source Development OTE and firms which are established as well as firms who have existing S

apply order for proposed item need not to participate in this tender enquiry. Such offer(s) shall be summarily rejected.

(c) Please submit following documents which are mandatory at the time of bidding, failing which the bid of the firm shall be summarily rejected:

(viii) PRE-QUALIFICATION CRITERIA :

Vendor will be eligible for participating against the requirement of PCBs on the basis of following conditions:-

- Only manufacturer of electronic assemblies, having assembly line for axial (wave soldering machine) and SMD components {like ESD safe Temp. Controlled Soldering Stations, screen printer, pick and place machine, reflow oven, Optical inspection system and X-ray (optional)} etc. will be eligible.

- Vendor must have maintained ESD safe clean room area of class 100000 for assembly.

- Vendor must have calibrated (from NABL accredited labs) measuring/testing equipments used for testing of the PCBs.

- Vendor should have qualified manpower capable of identification and handling of ESD safe electronics components.

- Vendor must have at least three years of experience of supplying the similar type of MIL grade or other high end PCBs to Indian Army/Government departments or to reputed private firms.

- All the PCBs are double sided PTH PCBs and the firm has to develop the Gerber on its own from the schematic Diagram and the layout Diagram provided by OLF.

- All assembled PCBs submitted by the vendor will be tested for functional at Normal climatic conditions on dedicated test stand available at OLF. After acceptance of the PCBs firm will depute the rep. to OLF for 03 layers Varnish/laquer (MIL/JSS approved) coating at OLF followed by testing at HOT +50°/COLD -30° and finally integration in higher assembly.

- Documentary proof for the above mentioned points is to be submitted by the firms along with the bid.

(d) Splitting will be as below depending upon TE participation : Not Applicable

(e) Compliance Statement is required as per Annexure-I.

(f) Editing is not allowed in clauses of Compliance statement, any clarifications/ deviations from bidders would be written in the remark section of Compliance statement.

(g) Bidder may please note that GeM is capturing and showing the IP addresses used by the buyer and Bidder(s)/Seller(s). The received bids having matching/common IP addresses with either Bidder(s)/Seller(s) or Buyer, shall be outrightly rejected & shall not be considered for further evaluation.

(h) Tender Clause for restriction on procurement from a bidder of a country which shares a land border with India :

(i) Any firm from a country which shares a land border with India will be eligible to bid in this TE only if the bidder is registered with the Competent Authority (i.e. Registration Committee constituted by Department for promotion of Industry & Internal Trade(DPIIT)(Rule 144xi of the General Financial Rules 2017).

(i) VENDORS REGISTRATION:

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
