If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Vendor should quote prices as per above only. Offers indicating rates anywhere else (scanned documents etc.) shall be liable for rejection.

- 1) Past work experience:
 - 1) Bidder shall submit at least one executed PO copy for overhauling of Steam Turbine Emergency Stop Valve OR Steam turbine rotor of turbine rating not less than 5 MW or higher in Fertilizers /Refineries/ Petrochemical/ Oil and gas and Power Plants only during last seven years ending last date of month previous to the one in which application are invited.
- 2) Bidder shall submit completion certificate / documents indicating work completion issued by clients clearly corresponding to the submitted works orders. (Delivery Challan / Tax Invoice / Payment Advice).
- 3) Party should have their own facility for Positive Material Identification of material (PMI machine), Reverse Engineering & 3 D Scanning machine for internal parts for preparation of drawings. Party shall submit details of all such as model no., make of machine or machine nameplate, photographs of installed machines at party's own work along with the offer for evaluation.

Note:-

- a) Bidder shall submit executed work order/purchase order copy for fulfilling the above-mentioned criteria. This work order must be issued & executed in the last 07 (seven) years ending the last day of month previous to the one in which this subject tender is floated/issued.
- b) Proof of execution of the submitted PO/ Work-orders, Bidder shall submit any of the following:
1. Completion certificate / Customer Acceptance Certificate OR
 2. GeM CRAC (Consignee Receipt and Acceptance Certificate) document OR
 3. (i). Tax Invoice to the extent of required Pre-Qualification value and

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
