OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

##### 3. Generic

Products supplied shall be nontoxic and harmless to health. In the case of toxic materials, Material Safety Data Sheet may be furnished along with the material.

##### 4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

**5. Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

**6. Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

**7. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**8. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The contract will be valid for a period of 2 years with effect from award of the contract which may be extended further one year on the same terms & conditions. However, The grant of extension of contract will be sole discretion of this office i.e. NSO (FOD) Hqrs, Delhi.
2. This office reserve the right to terminate the contract/bid at any time without assigning any reason.
3. The work is to be carried out in the premises of this office. Only such works which can not be done in the office premises, would be allowed to be done bidder's office after taking necessary approval of this office . No extra charges will be payable on this ground.
4. Contractor/successful bidder shall be fully responsible for theft, burglary, fire or any mischievous deeds by his deployed staff. Any violation or breach of faith will attract severe action including cancellation of the contract. The firm may also be black-listed for future dealings with the Government. Besides, the firm will also be liable for prosecution under local laws. The firm, therefore, in their own interest, deploy personnel with proved credentials with proper supervision so that no breach of trust occurs during the currency of the contract. Any damages/wear & tear caused to the machine used in Sankhyiki Bhawan will be borne by the Contractor, no additional payment will be made to Contractor by this office.
5. In case of breach of any of the terms and conditions mentioned herein, this office will have the right to cancel the contract without assigning any reason thereof and nothing will be payable by this office.
6. The payment will be made on pro-rata basis after satisfactory completion of the job.
7. The bidders must submit their PAN/GST number and enclose a photocopy thereof.
8. The firm shall not assign or sublet the work or any part of it to any other person or party.
9. The Service Provider should not have been black-listed by any Central/ State Government Agency. Bidders will submit self-declaration certificate in proper format.
10. No interim bills will be entertained. The bill payment will be subject to TDS applicable under the Income Tax Act, 1961 and the Goods and Services Act, 2017.
