1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
  1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

5. Tenderer must have submit Service & Support Availability of Office of Service Provider. An Office of the Service provider must be located in the state of Consignee Documentary evidence to be submitted.

8. Experience of having successfully completed similar works during last 07 years ending last day of month previous to the one in which applications are invited should be either of following.

A. Three similar completed works costing not less than the amount equal to 40% of the estimate cost

OR

**B.** Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

OR

**C.** One similar completed work costing not less than the amount equal to 80% of the estimated cost.

9. Satisfactory work completion certificate by concerned Executive Engineer/Engineer of Contract is required to be submitted.

Relevant documents in support of the above must be furnished. If these documents are not furnished along with the tender Part-I, the offer will be liable to be rejected summarily

**4. Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

1. The Diesel vehicle should be in show room/good condition and BS6 Model.
2. The cost of the fuel shall be borne by the Department.
3. The vehicle will be used for UPPTCL work only and in no condition shall be utilized by the contractor during the period of Contract.
4. Maintenance/repairing cost etc. will be borne by the contractor and in case of any break down/emergency another vehicle will be provided by the contractor within 8Hrs. otherwise necessary deductions shall be made from his bills. The vehicle should have all India permit and all taxes insurance etc. should be paid by the contractor up to date and photocopy of all documents shall be made available in this office before providing the vehicle.
5. The driver should be experienced and having driving license. Any challan due to driver negligence/offence shall be borne by the contractor, and contractor shall be responsible for it.
6. Minimum average of 12 kms/ltr.with diesel should be ensured.
7. The vehicle can be used any time 24 hours.
8. The log book shall be maintained by Engineer instructed by SE, ETC, GR. NOIDA.
9. If vehicle remains out of order for more than 12 hrs. the rent of the day will not be paid.
10. Vehicle will be used for out station journey for deptt. Work as and when required.
11. Double the charge of daily rate will be deducted from bill if vehicle is detained by owner without any reason/information.

**In case of any accident, no claim will be accepted by deptt.**

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
