- I The bidder shall be the original manufacturer or authorized dealer/representative of original manufacturer. The authorized representative shall provide a valid certificate of authorization from the original manufacturer.
- I The bidder is required to attach the detailed specifications and performance data along with the quotation. The part number and make / model etc. should also be clearly mentioned. In the absence of these details, the quotation will not be considered.
- I A compliance table for tender specifications and offered specifications should be submitted.
- I Bidder must submit certificate from the original manufacturer for the respective clone details of these antibodies.
- I Uploaded Quoted model Catalogue should be authenticated by Website of the original manufacturers and in the absence of website authentication, the quotation will not be considered.
