provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. (iii) The seller fails to deliver the material (s) or any part thereof within the stipulated delivery period and/ or to replace/rectify any rejected or defective material (s) promptly.

(iv) The seller becomes bankrupt or goes into liquidation.

(V) The seller makes a general assignment for the benefits of creditors.

(vi) A receiver is appointed for any substantial property owned by the seller.

(vii) The seller has misrepresented to Buyer, acting or which misrepresentation Buyer has placed the Purchase Order on the Seller.

Generic

Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent.)

FINANCIAL CRITERIA

NETWORTH : Net worth of the OEM should be positive as per last audited financial statement.

COMMON IP ADDRESSES

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
