1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Submission of EMD is mandatory for all. No exemption will be allowed. Bidders can also submit the EMD in form of DD and Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

The bidder must have to submit an acceptance on INR 100 Non-Judicial Stamp duly notarized that there will be no objection taken from any bidder for this tender for qualify and disqualify to any bidder.
