**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 5. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

#### **Scope of work/Terms and conditions for CAMC of Agilent Make ICPMS**

The bidder has to undertake the following terms and conditions

- a) Bidder has to support unlimited breakdown visits
- b) Bidder should undertake one preventive maintenance visit with PM kit.
- c) Bidder should undertake unlimited phone support (Software and Hardware).
- d) All parts required for repair of the instrument has to be supplied by bidder. CAMC charges includes this expenditure.
- e) Chiller and Autosampler are not covered under CAMC.
- f) EGS (End of Guarantee support) all module and spares which have crossed EGS, service and spares should be provided on best effort basis.
- g) Service should be provided in normal working hours and normal working days except in case of emergency.
- h) Payments will be made half yearly once i.e., two instalments in one year. Bidder has to generate the invoice after completion of first 6 months from contract start date.
