However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. The name of the Purchaser of stamp paper may either be the executing Bank or the party on whose behalf the BG is issued.

In certain States, the Rules permit levy of stamp duty by the process of franking under signature of empowered officer. Such BG may also be accepted as duly stamped.

v). Successful Bidder shall submit PBG (if applicable) within 30 days from the date of GeM Contract, failing which the PBG amount shall be retained from initial invoices. The PBG must be valid for 03 months beyond the Delivery Period as specified in the Contract.

vi) **NOTE: (a) Format of BG: The Bid Security/EMD shall be in the form of Bank Guarantee only, the format of the Bank Guarantee shall be in accordance of enclosed format in ATC (Form of Bank Guarantee towards Bid security), BG in any other format shall not be accepted.**

(b) **NOTE: Bidders seeking EMD exemption must submit Properly Filled Undertaking ANNEXURE -A1, which is attached in ATC.**
