The receipt of the sample submission should be uploaded along with all other relevant documents before the closing of the bid. 2. a) Specification - size= 22x50 mm b). Manufacturing license, such as ISO / BIS, should be submitted along with the bid documents.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
