2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Bidders are requested to read carefully the detailed specifications & Terms and Conditions before submission of this Tender Inquiry.
2. Bidders are requested to submit all the documents and Specification compliance document as asked in ATC of the bid, otherwise their offer will be liable for rejection.
3. Bidders /Firms bidding in common IP address with any other firm will be rejected straight away without verifying any documents and their representation will not be considered. Firms bidding in single IP address only be allowed for technical evaluation.
 4. Firm should comply with the Bid Requirements as per GeM Bid.
 5. Firm should upload scope of work duly acknowledged & signed.
 6. Firm shall have experience and successfully executed more than 90% accuracy in at least one supply order for similar type of work of Artificial Intelligence (AI) based Automated Defect Recognition (ADR) software development to any central or state Govt. of India/ PSUs/DPSUs/Public Listed company/ establishments in last five years completed on last date of the previous month in which the tender published. Bidder shall submit the supporting documents along with the technical bid. However Govt. regulations on the exemption will prevail on the exemption category firms, if any.
 7. Bidder shall enclose supporting documents e.g. copies of supply order and tax invoice / consignment note while submitting Technical Bid.
 8. Bidder shall provide copies of audited Balance Sheet and profit and loss statements for last three financial years to prove its financial standing.
9. Submission of false/ misleading/ forged documents may lead to rejection of bid & initiation of suitable action as per MILSPM & GeM policy.
10. As per MILSPM-2023, exemption for EMD and Purchase preference to MSE firms shall be given & the bids shall be PPP-MII compliant. For this firm has to submit valid copy of relevant certificate/document and opt for the same during bidding.
 11. Non-submission of any of the document mentioned under point No. 29 i.e. Essential documents for Technical Qualification may lead to disqualification in technical evaluation.
12. Bidder shall not disclose/ share any technical information/ documents in any form to any 'Third Party' without prior written consent of OFBL. Non-Disclosure Agreement (NDA) shall be signed between the vendor and buyer before the work is started.
13. Firm should comply with the Bid Requirements as per GeM Bid.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
