### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1.1 The preventive maintenance & inspection work should be carried out at quarterly.
- 1.2 Any Break down intimated through phone/fax should attend within 48 Hours.
- 1.3 Payment Terms: Payment to be made quarterly within 30 days, after satisfactory preventive maintenance and on presentation of bills along with original service reports duly certified by Engineer and approved by HOD
- 1.4 The working hours of the facility are from 8:00 AM to 4:00 PM on all regular working days Monday to Saturday. During contingencies the personnel may have to work in the extended hours on regular working days and on holidays.
