1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 4. 5. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- The Seller fails to comply with any material term of the Contract.
- The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- The Seller becomes bankrupt or goes into liquidation.
- The Seller makes a general assignment for the benefit of creditors.
- A receiver is appointed for any substantial property owned by the Seller.
- The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

General Terms & Conditions for the bidders:

1. This bid is for the purchase of new products only; no refurbished or manually customized products will be entertained.
2. Incoterms: FOR (free delivery at) Shree Narayan Eye Hospital, Tajpura Halol, Tajpura - 389350, Vadodara, Gujarat. Goods will be invoiced to Bharat EElectronics Limited, Pune.
3. Delivery Address: Shree Narayan Eye Hospital, Tajpura Halol, Tajpura - 389350, Vadodara, Gujarat.
4. Delivery Schedule and T&C: Supplier is required to arrange to deliver the item at delivery address free of cost within 4-6 week's time after intimation from BEL. The Invoice (duly stamped & signed) for the same shall be forwarded to BEL, Pune for payment on receipt and acceptance of goods at delivery address.
5. Installation, Commissioning and Training - The supplier is required to arrange to Install and Commission the goods at the delivery address along with a demo to the concerned persons on how to use the product. For the timely and smooth installation and commissioning of the units, the supplier must coordinate with the concerned persons at hospital and operationalize the units as per its requirement.
6. Any repair / rework / replacement after delivery under warranty is required to be arranged by supplier with OEM representative free of charge without fail approximately within 1 to 2 week's time at delivery address in coordination with the hospital administration.

11. LD Clause: Time is the essence of contract and the materials against this Purchase Order must be delivered by the supplier according to the delivery schedule indicated in the Purchase Order. In case of any change, the supplier should inform BEL in advance and obtain the approval for the revised delivery schedule. Should the supplier fail to deliver the materials or part thereof as per the agreed delivery schedule, BEL shall be entitled at BEL's option either a) to recover from the supplier

as agreed, liquidated damages a sum equivalent to 0.5% of the value of materials not supplied in time for every week's delay or part thereof subject to maximum of 10% or b) purchase material elsewhere at the risk and cost of the supplier, or c) to cancel the Order. In the event of action being taken under b) & c) the supplier shall be liable for any loss which BEL may sustain but the supplier shall not be entitled to any gain on repurchase made against default.

12. OEM authorization is required, if bidder is quoting on behalf of OEM.
