3. The tenderer in his own interest shall inspect the site of the proposed work, understand terms and conditions of the contract before quoting the rates.
4. Price breakup sheet is available in detailed tender document for financial bid. Do not upload price breakup sheet along with technical bid.
5. Kindly note that rates are inclusive of Mechanized Cleaning , Manual Cleaning including Ragpicking, garbage disposal, and pest and rodent control (inclusive of GST @ 18%).

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
