The authenticity of the self-certificate as well as other documents submitted/uploaded by the bidder will solely be their responsibility and appropriate action will be taken by CIL/Subsidiary Company if it is subsequently found to be misleading/ false/ forged.

However, the Purchaser reserves the right to obtain the performance directly from the end user of the item/product.

**10) Indigenous (Local) Manufacturers/ Foreign Manufacturers:** If the manufacturer does not quote directly to any organizations in India as a matter of its corporate policy (except in situations like OEM/OES/OPM, supplies of spares and consumables bundles with supply of equipment, supplies to consumers not covered by dealer network due to geographical/ logistic constraints), the manufacturer can authorize its Indian Agent through the tender specific authorization issued by the manufacturer mentioning tender reference number and date and validity of such authorization.

The manufacturer is also required to submit a certificate that it is not quoting directly against the tenders of any organization in India (excepting the situation mentioned above, if applicable) as a matter of its corporate policy and if, subsequently, at any stage, it is found that it has quoted directly to any organization in India excepting the situation mentioned above, it shall be liable for penal action as per provision of **CIL Purchase Manual 2020 and its subsequent amendments and guidelines**, if the jurisdiction provided by the bidder has not been considered adequate and satisfactory by the procuring entity.

**Purchase preference to MII is applicable as per Government of India guidelines as applicable from time to time. Exemption under MII is applicable as per Order No. - P-45021/2/2017-PP (BE-II)-Part (4) Vol. II Dt. 19.07.2024 or its latest amendment issued by DPIIT, Ministry of commerce and Industry, Government of India.**

**11) One manufacturer can authorize only one agent:** One manufacturer can authorize only one agent. The manufacturer can authorize its agent through the tender specific authorization issued by the manufacturer mentioning tender reference number and date and validity of such authorization.

In case where one manufacturer provides authorization to multiple agents against one tender, in such case the manufacturer may provide self-declaration declaring that the product is commercially available off-the-shelf and general authorization/ dealership / distributorship certificate is considered in place of tender specific authorization. Failing which all the bidders authorized by the manufacturer are liable for rejection without any communication further.

The relaxation against 'One manufacture can authorize one agent' is applicable in case of system integrators for products/ solutions involving hardware, software and their integration solutions of a number of manufacturers/ vendors.

**12) Vendor Assessment in GeM:** The Vendor who wish to claim preference against manufacturer of the bid materials, need to upload relevant documents to prove that they have been registered as manufacturer for bid relevant materials through vendor assessment in GeM.

**13) Price Fall Clause:**

If the contract holder reduces its price or sells or even offers to sell the contracted goods or services following conditions of sale similar to those of the contract, at a price lower than the contract price, to any person or organization during the currency of the contract, the contract price will be automatically reduced with effect from that date for all the subsequent supplies under the contract and the contract be amended accordingly.

In case of parallel Rate / Running Contracts, if the price of a product is reduced for any supplier due to invocation of 'Price Fall clause' or any other reason, the same lower price shall also be applicable for the other suppliers who are having parallel RCs against the same tender. If any parallel RC holder does not accept the lower price, CIL shall have the right to delete the item from the scope of RC of such firm and procure the same from other existing supplier / Reserve RC holders.

The provisions of price fall clause will however not apply to the following:

- i) Export/Deemed Export by the supplier;
- ii) Sale of goods or services as original equipment prices lower than the price charged for normal replacement;
- iii) Sale of goods such as drugs, which have expiry date;

iv) Sale of goods or services at lower price

a) on or after the date of completion of sale/placement of order of goods or services by the authority concerned, under the existing or previous Rate Contracts

b) Under any previous contracts entered into with the Central or State Government Departments including new undertakings (excluding joint sector companies and or private parties) and bodies.

Note:

a. The currency of contract will mean the period till completion of supply.

b. The bidder will be asked to submit a copy of the latest purchase order (bidder may opt to mask the price portion and shall submit an undertaking that priced copy will be submitted on being L1 after opening of Price Bid / Reverse Auction) for the tendered / similar item(s) received by them from any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU, along with the offer.

In case the bidder has not received any purchase order for the tendered / similar item(s) from any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU, they need to submit a self-certificate as under:

"It is hereby certified that, We..... (Name of the Firm), have not received any order for the tendered / similar item(s) from any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and / or its Subsidiaries or other PSU."

c. It shall be responsibility of the supplier to inform the purchaser of offer to supply / supply of the ordered / similar item(s) at a lower rate to any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU during the currency of the contract.

d. The supplier shall submit a certificate along with the bill(s) as under:-

"I/We certify that there has been no reduction in the sale price of the offered / supplied goods under this contract or similar item(s) and such goods have not been offered/sold by me/ us to any Organization / Ministry / Department of the Govt. of India or Coal India Ltd. and/or its Subsidiaries or other PSU, as the case may be, during the currency of the contract at a price lower than the price charged under the contract."

**Note:** The Price Fall Clause is relaxed for purchase value below Rs. 2.00 lakh. [Annexure V is mandatory for participating in bid value of above 2.00 lakhs. Provisions of price fall clause shall not apply to cases as indicated above.](#)

14) The Procuring Entity reserves its right to accept or reject any or all Bids, abandon/ cancel the Tender process, and issue another tender for the same or similar Goods at any time before the award of the contract. It would have no liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for such action(s).

**15) EMD: Earnest Money Deposit (EMD):** The tenderers will have to submit EMD for the 2% of the estimated value including all taxes, duties and other costs and charges along with their bids. The same shall be submitted within time as per GTC of GeM.

In case of item wise evaluation of Bid, the EMD value will be proportionally distributed as per the estimate value of the Schedules and in line with the provision available in GeM Portal.

The bidder claiming exemption in case of Open Tender from paying EMD must submit undertaking as per Annexure III. Exemption is applicable as per GTC of GeM and provisions of CIL Purchase Manual and other circular/guidelines/order as applicable from time to time.

EMD is exempted for bidders who are :

(a) Registered with CIL / Subsidiary Company, Ancillary units of subsidiary company, NSIC, MSEs as defined in clause-2.8.2.1, Startups and Central/ State Government Organizations/ PSUs irrespective of the stores for which they are registered.

(b) In case of Single Tender Enquiry - both with PAC and without PAC are exempted.

(c) OEM/ OES participating in Open/Limited tenders for procurement of Spare Parts for their equipment are also exempted.

(d) EMD is not applicable for bid with estimated bid values upto 5 Lakhs.

(e) Submission of EMD is exempted in case of Trial / Developmental Tenders.

**16) Security Deposit:** The successful tenderers will have to submit Security Deposit/SDBG for the 5% value of the total landed value of the contract including all taxes, duties and other costs and charges, without considering Input Tax Credit. The Same shall be submitted within time as per GTC of GeM. Security Deposit is exempted for bid with estimated bid values upto 5 Lakhs. Security Deposit will be released within 30 days after completion of supplies and acceptance of materials by the consignee. All Central/State Government Organisation/PSU shall be exempted from submission of SD. OEM/OES shall also be exempted from submission of SD in case of procurement of spares parts for equipment against Single Tender Enquiry/Open/Limited Tenders. In case of consumable spares if e-PBG as per GeM is applicable, No SD/SDBG shall be applicable. The SDBG shall remain valid up to three months after completion of supplies and acceptance of materials by consignee.

In case of item wise evaluation of Bid, the SD value will be proportionally distributed as per the contract value for bid with estimate value above 5 Lakhs.

**17) Payment Terms:** Payments shall be made to the seller within 21 days of issue of Consignee Receipt-cum- Acceptance Certificate (CRAC) and online submission of bills (This is in suppression of 10 days timeline as provided in clause 12 of GeM GTC.

**18) Risk Purchase:** - In the event of failure to deliver the materials within the stipulated period Bankola Area, ECL has the right to purchase the materials from other sources with due notice and at the risk and cost of the defaulting supplier.

**19) Banned or Delisted or Debarred or 'Put on Holiday' Suppliers:** The bidder as well as the manufacturer (if bidder is not the manufacturer) will give a declaration that they have not been banned or de-listed or debarred or 'Put on Holiday' by any Government or quasi-Government agencies or PSUs. If a bidder and/or manufacturer has been banned or delisted or debarred or 'Put on Holiday' by any Government or quasi-Government agencies or PSU, this fact must be clearly stated and it may not necessarily be a cause for disqualifying them. If this declaration as per Annexure VI is not given, the bid will be rejected as non-responsive.

20) The bidder is solely responsible for the legality/authenticity of all the information(s) and document(s) provided from time to time during the tendering process upto the end of material Guaranty and Warranty period, if awarded contract.

**21) Jurisdiction:** Any dispute arising out shall come under the sole jurisdiction of Asansol Court (West Bengal).

## **22) Relaxing Prior experience and turnover criteria for start-ups and MSEs**

As per Policy Circular No.1(2)(1)/2016-MA dated 10.03.2016 of MoMSME, it has been clarified that all Central Ministries/ Departments/ Central Public Sector Undertakings may relax the condition of prior turnover and prior experience with respect to Micro and Small Enterprises in all public procurements subject to meeting of quality and technical specifications, i.e. these MSEs must have the technical capability to deliver the goods and services as per prescribed technical and quality specifications. Further, as per Department of Expenditure, Ministry of Finance OM No. F.20/2/2014/PPD-(Pt) dated 25.07.2016 circulated vide note F. No. 24/2/2013/Fin-1 dated 02.08.2016, relaxation of the condition of prior turnover and prior experience in public procurement has been extended to all Startups (whether MSE or not) subject to meeting of quality and technical specifications in accordance with the relevant provisions [Rule 173(i)(b) of GFR, 2017].

However, if the bidders in their offer have submitted documents to prove the Startup/MSE status for the tendered item without certificate towards quality, assurance and capability from some authority like MSME, NSIC, etc., the TIA, if needed, may assess the techno-commercial capability of the vendors to manufacture and deliver goods as per the prescribed quality and technical specification before awarding contract to them. For this purpose, such MSEs/ Startups should submit the details of plant & machinery, quality control arrangements, location of manufacturing works/ factory, etc., along with their bids for verification of their technical capability in the desired format in Annexure-1. After opening of bids, the verification of technical capability may be done by the concerned Technical Department immediately without any undue delay so that it is available for consideration at the time of evaluation/ processing of offers.

It should be ensured that the designated technical authority from whom the technical capability report is being called, is furnished with copy of the enquiry, the details of equipment, quality control, man-power availability, compliance/ deviation statements and any other relevant particulars related to manufacturing/supply of the item as furnished by the firm(s) along with their tender.

If required, a techno-commercial team of the organization may visit the manufacturing unit of the vendor without any undue delay for quick finalization of tenders.

In case there is deficiency in technical capability of the firm, the same is to be communicated to them by TIA for improvement in the quality of their product for future tenders and clearly indicate that their offer cannot be considered for relaxation against the tender in question in order to avoid any future complications. The issues relating to technical capability may be decided by the Head of the Technical Department.

If favorable technical capability reports obtained earlier on such firms for supply of the item in question as per the required specification is available, these may be considered for granting relaxation to the criteria of prior experience and prior turnover provided date of such reports are not more than one year from the date of opening of bids.

If bidders have submitted documents to prove the Startup/MSE status for the tendered item and their products are ISI marked/DGMS approved/Proven in CIL or its Subsidiary companies/Proven product of the ancillary unit of a Subsidiary Company of CIL, they will be required to submit

t the following applicable related documents, duly notarized, for relaxation from the criteria of prior experience and prior turnover:

- a valid BIS Marking License for the quoted items

or

- Rate contract issued by CIL/its Subsidiary Companies for the quoted items

or

- a valid DGMS Approval certificate for the quoted items

or

- Proven Ancillary certificate issued by the Subsidiary Companies for the quoted items.

The document(s)/certificate(s) furnished by the bidders for ISI markings or DGMS approval for any relaxation should be valid on the date of tender opening and a copy of such document(s)/certificate(s) valid on the date of supply, duly notarized, must accompany their bill(s).

**Note:** ECL may prefer the vendors to have prior experience rather than giving orders to new entities for procurement of items related to public safety, health, critical security operations and equipment, etc. inline with clarification given by Department of Expenditure, MoF vide OM No. F.20/2/2014/PPD-(Pt) dated 20.09.2016.

Note: Public Procurement Policy is meant for procurement of only goods produced and services rendered by MSEs. However, trader/distributors/supplier agent/works contract are excluded from the purview of Purview of Public Procurement Policy for MSEs.Order,2012 as per office memorandum vide F.No.1(3)/2018-MA, Part-III dated 25.03.2022 regarding FAQs in respect of Public Procurement Policy for MSEs Order,2012-reg.

**23)** In case any bidder is seeking exemption from Experience/Turnover Criteria, the supporting documents to prove his eligibility must be uploaded for evaluation by buyer

Following documents are mandatory for claiming Exemption from Experience in case of Open Tender.

- MSE Udyam Certificate/ Startup Certificate/ NISC Certificate/GeM Vendor Assessment Report etc
- Completely filled Annexure I
- Completely filled Annexure IA

**24) TReDS:** Trade Receivables Discounting System (TReDS) is an initiative of Reserve bank of India (RBI) to facilitate MSME receivable payments from corporates. ECL has on boarded TReDS platform thro' Receivables Exchange of India Ltd (RXIL) (URL - <https://www.rxil.in/Home/Index>). MSE bidders willing to get payment thro' this system may get registered on TReDS platform and confirm in offer and the same would be mentioned in the purchase order.
