2.1 TECHNICAL ELIGIBILITY CRITERIA:- The evaluation of technical eligibility of bidders will be viewed in terms of GCC-2018 For service & its amendments enforced on the subject wo

rk. For more details please refer relevant clause No. 2.6 & its applicable sub clauses of GCC-2018 for service and its amendment for all Minimum & Technical eligibility criteria of the work.

2.2. MINIMUM ELIGIBILITY CRITERIA APPLICABLE ON THE WORK.

A. WORK EXPERIENCE.

- 1). The bidder should have satisfactorily completed in the last three previous financial years and the current financial year upto the date of opening of the tender, one similar single service contract for a minimum of 35% of advertised value of the bid.

Completed service contract includes on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of the bid.

- 2) **DEFINITION OF SIMILAR TYPE OF WORK:-** For the subject work "Management of Running room services and supply of readymade subsidized meals to running staff in running room", The Definition of similar work approved by PCEE/Central Railway is as under,

"Housekeeping along with catering (including meals) of Railway running Rooms/Railway rest house/Railway Training Institute hostels/Public Sector Undertakings/ any other installation/office of Central Government/State Government, OR of public listed company/private company/Trusts (having annual turnover of Rs 500 crore and above subject to the work completion certificate being issued from their Head office by a person of the company duly enclosing his authorisation by the Management for issuing such credentials)."

B. FINANCIAL STANDING:-The bidder will qualify only if they have the minimum following financial capabilities as below :-

- i) **T1- Financial Turnover-** The bidder should have an aggregate financial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year upto the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership number shall be considered.

ii) T2-Liquidity:-

The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5 % of the estimated bid value net of applicant's commitments for other contracts. The audited Last Financial year balance sheet and /or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along with bid.

If the last Financial Year Balance sheet is not audited only then Provisional Balance sheet of last financial year duly certified by chartered accountant with stamp, signature and membership number should be submitted along with the Bid.

In case of banking reference issued by bank, Railway shall independently confirm the authenticity of the Banking reference from the issuing bank.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen from the Balance Sheets) are negative, only the Banking references will be considered. Otherwise, the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity.

- The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.
- In case of JV firms overall liquidity of JV firms shall be assessed by arithmetic sum of liquidity of all members of JV.

C. DECLARATIONS TO BE SUBMITTED BY BIDDERS WITH OFFER

- In terms of clause No. 2.6.2.1.3 of GCC-2018 for Service & its amendment, the bidder shall be required to submit an undertaking certifying the truthfulness of all the documents submitted uploaded along with the tender. This shall be mandatory for all the bidders. **In case of failure of the bidder to submit the undertaking, their offer shall be summarily rejected.** The sample format of the undertaking is given in ANNEXURE-I. The undertaking should be *DULYSTAMPED and SELF AT TESTED BY THE BIDDER.*
- In terms of GCC 2018 for Service clause No. 2.5, and its sub clauses- *Disqualification of Bidders*, the bidders are required to submit a declaration duly stamped and signed, in the format shown in **ANNEXURE-II.** Bids without declaration, in compliance to clause no. 2.5 and its sub clauses of GCC 2018 for Service, shall be disqualified/rejected and will not be considered for technical and financial evaluation.
- Bidders are also advised to submit declaration regarding not blacklisted or debarred and not suffered from bankruptcy/ insolvency as shown in **ANNEXURE-III.**

2.3. MINIMUM QUALIFYING SCORE.

- As per Clause.No.2.6 (B) of GCC-2018 for service, the method of evaluation of two packet system bids "Minimum Technical Eligibility Criteria" shall be used for all service contracts having bid value exceeding Rs. 50 lakhs.
- The bidder shall submit clear scanned (pdf) copy of documents / certificates in support of credentials along with the Bid document, in support of their claim to fulfill the minimum eligibility criteria as mentioned in the bid. In two packet system of bidding, each bidder shall be assigned score for their technical bid.

Bidders whose score is equal or above 60.00 out of maximum 100, shall be qualified for consideration of their financial bids. Bidders who do not meet the minimum qualification score of 60.00 shall not be considered further for opening of their financial bids. Unqualified bids shall not be considered further for award of the tender.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-

compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
