1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price

within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### 1. ATC :

- (i) The procurement of Annual Contract for Hiring of 12 Fireman through GeM Portal under Item category as Manpower outsourcing services –minimum wage skilled with scope of work as Annexure 'B' .
- ii. The firm should be having past experience for subject service or similar services involving skilled manpower in other Ordnance Factories / Central Govt / State Govt / PSU's / Autonomous Body. The firm shall enclose scanned copies of completed Supply Orders, Completion certificate to this effect.
- iii. Exemption in experience and turnover criteria shall not be exempted to MSES and Start up firms in this tender. All bidders , including MSES and Start-ups firms , **must have minimum 03 years experience in similar services.** Firms not meeting this requirement shall be treated as technically not suitable.
- ii. Annual Turnover of the Service Provider shall be (30% of the estimate value) i.e Rs. 16,62,127.5/- (Rs. 17 Lakhs rounded off as acceptable on GeM).
- ii. Firm has to submit copy of EPF,ESIC, GST Registration Certificate, PAN Card. and valid MSME certificate in which major activity is only for services. In MSME certificate if major activity is other than service, firm will not be considered qualified.
- ii. It is observed that many times outside firms had defaulted on statutory compliances and it becomes difficult to take action as labour welfare is a state subject , hence for better co-ordinations and effective control of manpower services the **vendor having GSTN registration whose official address of the enterprise in Tricity i.e. Mohali, Chandigarh & Panchkula are only permitted to participate. Vendor having GSTN registration other than Tricity will be rejected if participated.**
- iii. Firm should submit all the documents as required in the tender and should be uploaded by the firm along with the bid at the time of quoting for T.E., Firms not submitting document as mentioned in **Annexure A** (Uploaded in **Buyer uploaded ATC document** ) will be rejected during technical evaluation.
- iv. Firm has to submit declaration that no proceedings / Inquiry has been carried out remain unsettled / initiated / pending against the firm in the past by EPF Department /ESI Department / Labour or any other government department” as **Annexure C** (Uploaded in **Buyer uploaded ATC document** ). Firms offer will be disqualified for Non submission of Declaration Form i.e **Annexure C**
- ii. Firm should comply all terms & conditions as given in scope of work as Annexure 'B' and required to upload signed and stamped copy of scope of work with the bid at the time of quoting.
- ii. Firm has to submit valid Labour License from Labour Commissioner within a month for the contract (if awarded to

the firm) as per extent rules.

- ii. OFCd reserves the right to verify, cross check certificates of candidates and take physical test for qualifying nature only as mention in Scope of Work as per Annexure - B.
- ii. No candidate can be removed / terminated by the firm without prior notice to the individual and intimation to OFCd Management.
- iii. Payment to the contractor:

Monthly payment will be released to the contractor on submission of following documents to MM section:

- a. Attendance sheet duly countersigned by HOS of user section.
- b. Satisfactory job completion, which will be certified by DO &HOS of user section.
- c. Contractor has to make online payment to his manpower directly in their bank accounts. The contractor has to submit proof of transaction along with the bill duly counter signed by bank.
- d. Online EPF Challan & ECR sheet (if applicable).
- e. Online ESI Challan & contribution list.(if applicable).
- f. Contractor's Invoice& GST Invoice
- g. GST payment will be released after verification of invoice on GST portal.

T.D.S: - Income Tax/ TDS as applicable will be recovered as per statutory GOI rules from the bill while admitting of payment.

- ii. Payment of wages to the manpower (by contractor):
  - a. The contractor shall pay salary not less than the Central Minimum rate of wages fixed by the Office of the Asstt. Labour Commissioner (central), Ministry of Labour & Employment, New Delhi from time to time to the person engaged by him for the work. While quoting in T.E , this aspect must be taken care by the bidder & if any quote found lower than central minimum wages will summarily be rejected.
  - b. The contractor shall pay wages to the person under relevant category employed by him for the month on fixed day(s) but not later than 7<sup>th</sup> of the following month. In case of delayed payment appropriate penalty will be imposed.
  - c. Wages shall be paid without any deductions except those specified by special order or permissible under the Payments of Wages Act.

## ii. ARBITRATION

- a. All the disputes and differences arising out of or in connection with the present contract including the one connected with the validity of the present contract or any part thereof, should be settled by bilateral discussions.
- b. Any dispute disagreement of question arising out of or relating to this contract or relating to construction or performance (except as to any matter the decision or determination whereof is provided for these conditions), which cannot be settled amicably, to be referred by concerned party to the **India Optel Limited**, for appointment of the sole arbitrator. The arbitrator so appointed shall be a Govt. servant who had not dealt with matters to

which this agreement relates and in course of his duties had not expressed views on all or any of the matter in disputes or differences. The award to the Sole Arbitrator shall be final and binding on the parties.

- C. The venue of the arbitration shall be at place of concerned Factory i.e. Ordnance Factory Chandigarh.
- ii. All other terms and conditions shall be governed as per GeM.
- iii. Bid will be open in 21 days or as applicable on GeM portal.
- iv. L-1 Firm will be selected through GeM portal automatically.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
