2. 5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. An Undertaking on Bidder Letterhead with Seal and Signed copy should be uploaded of following

1) The bidder on its own cost shall arrange verification of emission reduction after the installation of RECDs at site from any of the labs approved by CPCB or SPCB or NGT or NABL.

2) The emission control Device/ Equipment intended to be used by the bidder shall be a valid Type approval certificate with COP (if applicable) for all ratings up to 800 kW rating of DG Set from any one of the four agencies as on date as approved by CPCB:

- a. Automotive Research Association of India, Pune (Maharashtra)
 - b. International Centre of Automotive Technology, Manesar (Haryana)
 - c. Indian Oil Corporation, Research and Development Centre, Faridabad (Haryana).
 - d. Indian Institute of Petroleum, Dehradun (Uttarakhand)
- 3) Bidder should confirm that there should not be any major component changes required other than Electrical Components throughout the life of RECD
- 4) DG Muffler should not be removed during the actual installation of RECD as mentioned in the CPCB System and Procedure Guideline PCLS/12/21-22 under section 4.1.2.3(f).
- 5) If the type approval certification has been received by removal of silencer during testing, ISO8528-10 noise standard compliance is mandatory for all makes of DG sets
- 6) RECD should not incorporate a Bypass system as mentioned in the CPCB System and Procedure Guideline PCLS/12/21-22 under section 4.7.4.
- 7) The back pressure should not increase the maximum prescribed backpressure limit by the Engine OEM throughout the RECD declared working life at full load across DG after installation of the DG sets
