AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Buyer Added Bid Specific ATC

1. Quote from bidder with service charges less than 6% shall not be considered.

2. One senior safety consultant education qualification and experience (graduation in science or engineering with minimum 15 years of experience in the field of health safety and environment (HSE) in various sec

tors like petro chemicals, manufacturing production, agro chemical, pharmaceuticals, ship repair industry, oil and gas industry, steel structural fabrications etc.

3. Six safety supervisors educational qualifications and experience (Graduation in science or engineering and diploma in industrial safety through SBTET, AP, minimum five years experience in the field of industrial safety.

4. Fifteen safety assistants education qualification and experience (Diploma in engineering/ graduation in science with diploma and industrial safety from SBTET, AP/ NEBOSH/ IOSH, minimum three years experience in the field of industrial safety.

5. Service level agreement (SLA), Scope of Work (SoW) and payment terms and conditions data required to be referred.

6. The purchaser reserves the right to increase or decrease the quantity to be ordered up to 100% bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the order quantity by up to 100% of the contracted quantity during the currency of the contract at the contracted rates. The bidder are bounded to accept the order accordingly.

7. In case of DP Extension, the awarded seller for the Contract is required to initiate a case for DP Extension 3 months prior to End Date of Contract along with revalidated PBG.

8. Quantum of LD:-

(a) If the vendor/ contractor fails to supply stores/ goods/ any installment thereof or fails to perform services, contract trials, installation of equipment, training and MET (Maintainability Evaluation Trials) as per schedule specified in a contract will be treated as a breach of contract.

Henceforth as per DPM 2025, 6.15.2, buyer has right to recover from the contractor, a sum equivalent to 0.5% of the total price for each week or part thereof. The total damage will not exceed 5% of the total price.

(b) In case of inordinate delay {more than one-fourth (25%) of the total delivery period), this maximum deduction shall be 10% of the total price.

9. Registered office should be located in Visakhapatnam Municipality area. Registered document should be submitted.

10. Attend Pre bid meeting on 02 Mar 2026 by 1400 Hrs at ND (V) compulsory. Mandatory Participation in pre bid conference. It is highly recommended that the firm must attend Pre bid conference to quality TEC considering the unique nature of work.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional

terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
