2) If there is a contradiction between GeM GTC and GCC of services, GCC of services will be prevailing.

3) Generic: Contractor shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

4) Generic: While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

6) Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
