If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. ## **Additional Terms & Condition Buyer Added Text**

**1. Availability of Office:** Office should be in the state of consignee i.e V isakhapatnam, Andhra Pradesh. Only GST Certificate and MSME Registration Certificate with local office address should be submitted as proof.

**2. Registration:** The Bidder should be registered with the Income Tax, Goods and Service Tax and also registered under the labour laws, Employees Provident Fund Organisation, Employees State Insurance Corporation.

In proof of having fully adhered to minimum eligibility criteria as mentioned above, attested copy of PAN, GST Registration, EPF Registration, ESIC Registration and Labour Licence shall only be acceptable.

**3. Clearance:** The Bidder should also have clearance from GST, and Income Tax Department. **The firm should produce valid GST Certificate, Valid Labour Registration Certificate of Consignee location i.e. (Andhra Pradesh, Visakhapatnam) failing to which the firm is liable for rejection.**

**4. Experience:** The Bidder should have at least 03 years of experience for providing manpower services in Ministries / Departments under Government of India

In proof of having fully adhered to minimum eligibility criteria as mentioned above, attested copy of work orders alongwith work completion certificates / ongoing work certificates issued by the Ministries / Departments under Government of India shall be acceptable.

**5. Turnover:** The Bidder should have minimum gross turnover in the similar business of providing manpower as per the bid document.

In proof of having fully adhered to minimum eligibility criteria as mentioned above, attested copy of the audited balance sheets (audited by Chartered Accountant) for the completed three financial year i.e. 2022-23, 2023-24 and 2024-25 shall only be acceptable.

**6. Self-Declaration:** That Contractor has not been suspended or blacklisted by any Unit/ Office of Indian Coast Guard, any other PSU or Govt. Agency and submit a declaration as follows:

**(i) "I/We hereby declare that I/we have not been Banned/ Suspended/ Blacklisted or de-listed by any PSU/ Government Department/ Financial Institution / Court."** In case, the declaration is found incorrect/false at any later stage, the tender is liable to be rejected, the contract shall be closed without any further notice and Incident will be raised as per GeM Terms and Conditions.

**(ii) I/We hereby declare that I/We have quoted service Charge 3.85% and above as per terms & condition of Bid Document.**

**7. Performance Guarantee:** The Bidder will be required to furnish a performance guarantee certificate by way of Bank Guarantee/ FDR through Public or Private Sector banks authorised to conduct government business of a total sum of 3% of the contract value.

**8. Paying Authority:** No advance payment will be done, payment will be made post completion of supply/ work through CDA(N), Vizag.

**9. Unsatisfactory Performance:** The Service provider is also likely to be rejected in case of unsatisfactory past performance in previous or ongoing contracts.

**10. Financial Position.** The firm should have a sound financial position to continue to provide service for a period of minimum of three months irrespective of clearance of bills by paying authority due to want of correct documents from service provider or any other unforeseen reasons. The payment should be made to the employees within one week of receiving attendance sheet from the buyer failing which the incident will

**11.** Firms should fill the certificates duly attached in the ATC and upload along with the other bid documents for technical evaluation. Firms falling to do so are liable for rejection.

**12.** Firms not replying to queries based on technical bids within the specified time will be rejected.

**13. Bid Security Declaration:** Bidders to sign a Bid securing declaration on firm's letter head accepting that if they withdraw or modify their bids during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document they will be suspended for the period of one year (time specified in the request for bids document) from being eligible to submit bids for contracts with entity that invited the bids. The bid declaration as per format be submitted along with other technical documents.

**14. Registered Local Office:** The Registered Office of participating firm is required to be located in consignee location to co-ordinate the services uninterrupted and to resolve any issues arising while carrying out contract as per contractual obligations. In support the service provider has to submit GST Certificate /MSME Registration Certificate with local address as documentary proof of office address, failing which the bid offer will be rejected during technical evaluation.

**15. The firm should produce valid GST Certificate of Consignee location i.e. (Andhra Pradesh, Visakhapatnam) failing to which the firm is liable for rejection.**

**16.** Bidder should have proper vendor code and should submit the documents like pan card, GSTIN, cancelled cheque, NEFT mandate duly certified by bank.

**17.** Buyer reserves all the rights to cancel the bid at any time without specifying the reasons.

**18.** In the matter of any dispute the decision of the buyer of the organisation will be final.

**19.** In case any mishappening/ casualty occur then there will be no responsibility of any officer of the organisation.

**20.** The firm should enclose Valid Labour Registration Certificate of Consignee Location i.e. (Andhra Pradesh, Visakhapatnam). Same should be submitted along with technical bids.

**21.** The contract awarded firm (L1 firm) must submit PBG of the contract within 15 days post award of the contract.

**22.** Non-submission of any of the information/ documents in the format attached with this proposal shall result in disqualification.

**23.** This Headquarters is proposed to opt the option via GeM portal only to choose L1 firm through "Manual selection" if available in place of "L1 Run by system" at the time of final selection .

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into**

force by the Government of India.

**For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.**

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
