OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or

2. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

1. Bidders are advised to quote single rates for the schedule 4. Rates quoted for the schedule 4 (Replacement of Items on need bases) above/below/par in percentage will be equally applicable for all individual scheduled items as given in Schedule of Rates and Quantities in Bid Form (Third Sheet) of attached Tender Document.

2. This tender shall be governed as per the Indian Railways General Condition of Contract for services-2018 as amended/corrected up to latest Correction Slips applicable up to the date of opening of tender and as well as other terms and conditions of contract as mentioned in this tender.

3. In case, any contradiction arises between GeM SLA and Indian Railways General Condition of Contract for services- 2018 as amended/corrected up to latest Correction Slips applicable up to the date of opening of tender and as well as other terms and conditions of contract as mentioned in this tender than later will prevail.

4. Bidder shall note that all the necessary mandatory/requisite information related to invited work is uploaded against various attachments. Bidder are advised to read all uploaded attachments carefully before participating in the bid.

5. Document received along with bid will only be considered for the bid evaluation. Any documents submitted later on or at the time of representation will not be considered for bid evaluation.

6. Bidder should go through the Check List of documents to be uploaded by the bidders (s) while submitting their offer.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
