### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

IMPORTANT NOTE:- 1. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

2. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates.

3. Bidder shall submit the following documents along with their bid for Vendor Code Creation: a. Copy of PAN Card. b. Copy of GSTIN. c. Copy of Cancelled Cheque. d. Copy of EFT Mandate duly certified by Bank.

4. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Accepting authority of tender/IOL Hqrs reserves the right to short close the order without assigning any reasons thereof.

6. Firm along with his bill has to submit separate EPF challan of the manpower engaged under the contract. Combined EPF challan of the other contracts will not be accepted for processing of bill under this contract.

7. The manpower working in Offices having a five day week may be allowed one day paid weekly off provided they have worked for a minimum of 40 hours during the said week. (OM.no.49019/95-Estt(C) dt.14/06/16. In addition, they will also be paid for a National Holiday, if it falls on a working day.

8. Bidders shall factor statutory bonus and ESI components strictly in accordance with the applicable wage ceilings. Any upward revision of wages crossing the statutory eligibility limits during the execution of the contract shall automatically render such category ineligible for the respective statutory benefit, and no additional financial implication on this account shall be admissible.

9. Office of the Service Provider must be located in the state of consignee i.e. Uttarakhand. Firm must enclosed any one of the following documents otherwise the firm technical bid will not be considered for technical evaluation.

a) Uttarakhand address of the firm must be registered in the MSME Certificate as a main address. Firm's Uttarakhand address register as a unit in the MSME Certificate will not be considered without document as mentioned below at (b) & (c) - -

b) Uttarakhand address of the firm must be registered in the GST document

c) Shop & Floor establishment certificate in the name of the firm & issued by the labour office of Uttarakhand.

In spite of these above documents { (a) or (b) or (c) } no other documents will be considered.

### अस्वीकरण/Disclaimer

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-**

**compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
